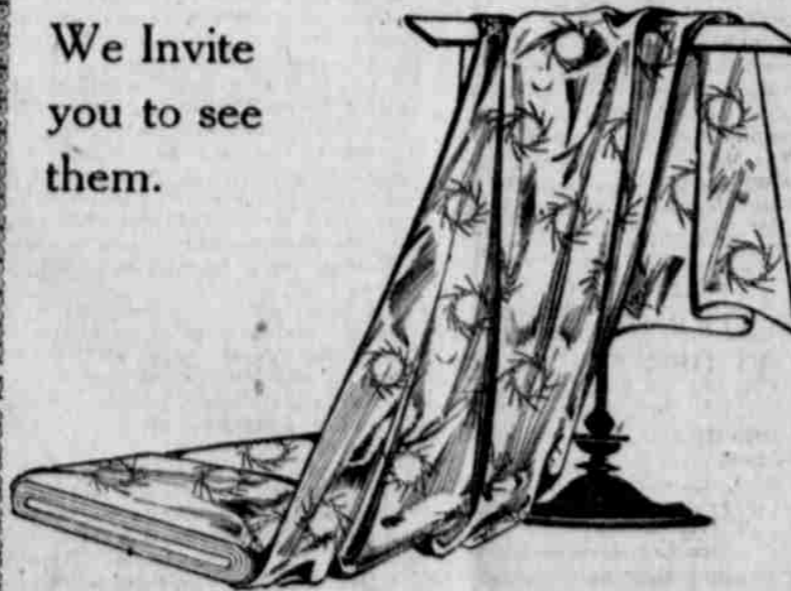

Improvements and extensions which will enable the Tumalo hatchery to take care of 4,000,000 trout eggs at one time are being rushed in order that the large quantity of spawn taken at Elk Lake this winter by Hatchery Superintendent Pearl Lynes, may be turned out as fry for planting in Central Oregon lakes and streams. In addition to 4,000,000 eggs for the present season it is planned to hatch 2,000,000 more of rainbow and redeye eggs early in the summer. The improvements now under way have been made possible through the work of W. C. Birdsall, who first conceived the idea of the hatchery on Tumalo Creek.

Plans outlined for this season, involving the expenditure of approximately \$6,000, include the extension of the main hatchery building 124 feet, making a total length of 200 feet, diking the creek, and construction of numerous concrete lined ponds, each from 20 to 40 feet long, in which the fry will be placed until they are sufficiently large for planting. Additional troughs are being constructed.

## MARCH 8 TO 12 IS M. E. DRIVE WEEK

March 8 to 12 is the period decided upon by the committee of the Methodist church when it will conduct its local drive among its members to assure the raising of sufficient funds to assure the erection of its proposed \$40,000 church in Bend.

According to Rev. J. Edgar Purdy, the church has promises of \$18,000 which sum for the building will be available contingent upon receiving outside appropriations for the building.

Plans are now being drawn for the new edifice by Leo A. Thomas and will be ready for publication within a few days.
