National Forest trails are open to two-wheel vehicles except where closed under Secretary of Agriculture regulations. Trails in Wild, Wilderness, and Primitive areas are closed as well as certain trails where vehicles would endanger the public...

About 15 per cent of the 18,000 miles of trails in the National Forests of Oregon and Washington are closed to motor vehicles. Most of the closure mileage is within Wilderness-type areas or in watersheds which supply water to cities.

Persons using vehicles on trails open to such use do so at their own risk, the Forest Service said. Safety of individuals and condition of trails cannot be guaranteed.

Forest Supervisors give public notice and most restrictions for each trail closure within their forest. Supervisor offices are located at Portland (Mt. Hood National Forest), Corvallis (Siuslaw), Eugene (Willamette), Roseburg (Umpqua), Grants Pass (Siskiyou), Medford (Rogue River), Klamath Falls (Winema), Lakeview (Fremont), Bend (Deschutes), Prineville (Ochoco), John Day (Malheur), Baker (Wallowa-Whitman), Pendleton (Umatilla), Vancouver (Gifford Pinchot), Olympia (Olympic), Seaside (Snoqualmie), Bellingham (Mt. Baker), Okanogan (Okanogan), and Wenatchee (Wenatchee).

Important vote on democracy is due in Peru

By United Press International The South American country of Peru conducts an important experiment in Democracy this coming Sunday June 9.

Two million Peruvian voters then will select a new president, two vice presidents and the total membership of Congress after nearly a year of military rule.

But this is not the only reason the election is important. It also will test the good intent of the military rulers who have promised that it will be free.

In elections last June, the man receiving the greatest number of votes was Peru's most controversial political character, Victor Raul Haya De La Torre.

Leans Left Haya De La Torre is a man with a Napoleonic face and figure who heightens his resemblance to the famous Corsican by brushing his forelock down over his forehead. As founder and leader of Peru's American Popular Revolutionary Action, or APRA, party, he spent years in exile and more years hiding out from Peruvian police in the Columbian Embassy in Lima.

He is considered a leftist of the same school as President Romulo Betancourt of Venezuela and President Juan Bosch of the Dominican Republic.

In Peru, he is suspect by the military and rightwing political groups, and prior to last year's elections, military leaders had vowed publicly that if elected he never would be permitted to take office.

After the elections, the military charged voting frauds and seized the government.

Same Men Run This year Haya De La Torre once more is a candidate.

In fact, all major candidates are the same as a year ago. The other two are Fernando Belaunde Terry, a professor of architecture and enthusiastic explorer of Peru's Andes mountains and jungles, and former President Manuel Prado.

Belaunde heads the Popular Action Party and Prado's organization is called the Prado Union. Neither has anything like the organization of Haya De La Torre's APRA party, which enjoys strong support from labor.

Impartial observers in Peru say the military junta there has done a good job in preparing for the coming elections.

New Rules Enacted A new election law has been written and is conceded to be non-discriminatory. A new registration of voters, with literacy a requirement, was carried out during the last year.

In Lima late last March this correspondent interviewed all three major candidates and then submitted questions to Gen. Nicholas Lindley, head of the ruling junta. Among the questions was one which asked if the junta would permit Haya De La Torre to take office now if elected.

The reply was non-committal. It said the question was "not pertinent" inasmuch as the junta had made no statement on the subject.

All three candidates are campaigning on platforms of anti-communism and cooperation with the Alliance for Progress. Differences primarily are ones of detail.

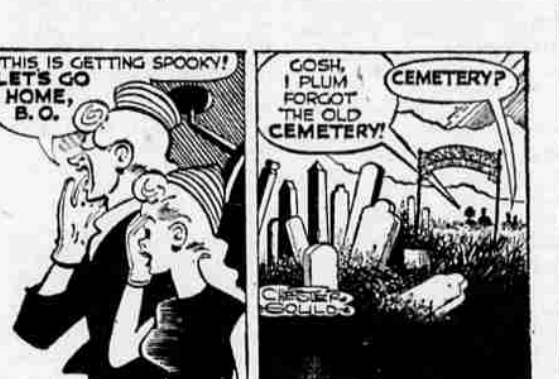

Another rise in sugar prices seen this year

WASHINGTON (UPI) - A congressional investigator predicted today the American consumer would be faced with another rise in sugar prices before the year's end. Rep. Charles A. Vanik, D-Ohio, made the forecast as a House bank currency subcommittee pressed its search for answers to the sharp rise in sugar prices.

The subcommittee today called the U.S. representative for Peruvian sugar producers to discuss the reason why Peru has fallen behind in supplying its committed quota of sugar to this country.

Vanik said he was not impressed with the argument of Agriculture Undersecretary Charles S. Murphy that the recent downward trend in prices would continue until they reached their normal level.

The Ohio Democrat said world sugar prices are up because consumers are willing to buy more sugar than the world now is producing. He blamed the underproduction partly on the sugar policy of the United States.

"We should buy sugar at the cheapest price," Vanik said in an interview, "even if it means buying all of it abroad."

More than 50 per cent of the sugar consumed in the United States is grown domestically. Vanik said that if the United States bought all of its sugar from foreign sources it would spur worldwide production to the point where supply would equal demand and prices would level off.

Vanik also had a suggestion on what American consumers could do now: buy less sugar. "Most of us could do without so much anyhow," he said.
