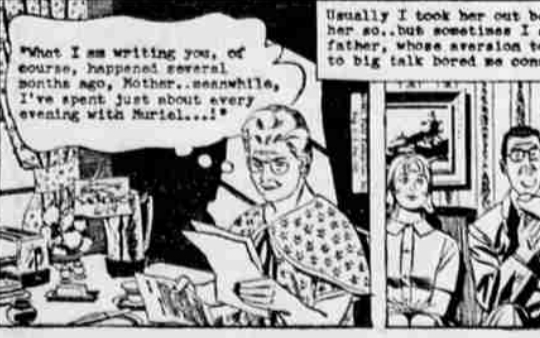

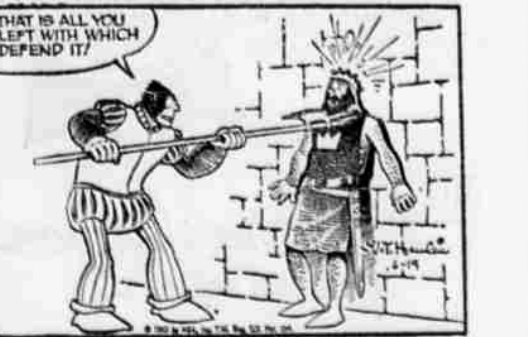

SALE OF TIMBER DEADMAN SPRINGS LOGGING UNITS. Sealed bids, in duplicate, on forms provided therefor, marked outside "Bid for Timber, Deadman Springs Logging Unit," addressed to the Superintendent, Warm Springs Indian Agency, Warm Springs, Oregon, will be received until 2:00 P.M., Pacific Daylight Savings Time, July 9th, 1963, for the purchase of timber within the Warm Springs Indian Reservation. The unit includes an area to be logged of approximately 6,110 acres. The total estimated volume to be cut is approximately 60,000,000 ft. B.M., of which approximately 300,000 ft. B.M. is green ponderosa pine and white pine, approximately 100,000 ft. B.M. is merchantable dead ponderosa pine and white pine, approximately 32,600,000 ft. B.M. is green Douglas fir, approximately 200,000 ft. B.M. is merchantable dead Douglas-fir, approximately 5,300,000 ft. B.M. is white fir, and approximately 500,000 ft. B.M. is other species, which estimates are not guaranteed. Each bidder must state the price per thousand feet BM Scribner Decimal C log scale that will be paid for timber cut and scaled. No bid will be considered for less than \$2.70 per thousand feet BM for green ponderosa pine and white pine, \$17.10 per thousand feet BM for green Douglas-fir, and \$6.20 per thousand feet BM for white fir. The stumpage price for other species shall be \$7.65 per thousand feet BM for the life of the contract and will not be subject to bidding or adjustment. The stumpage price for merchantable dead ponderosa pine and white pine and Douglas-fir shall always be 1/5 of the rate for green stumpage of the same species. A deposit of \$24,000.00 will be required as part of the purchase price of timber of this unit only, or retained as liquidated damages if the bidder fails to execute the contract and furnish satisfactory bond for \$20,000.00 within a period of 60 days after acceptance of his bid by the Commissioner, Bureau of Indian Affairs. The right to waive technical defects and reject any and all bids is reserved. The contract will specify that all designated timber shall be cut, and paid for on or before December 31, 1967. Construction of approximately 2.0 miles of main road and reconstructions of approximately 3.5 miles of existing road shall be completed on or before December 31, 1964; and all other obligations shall be met on or before December 31, 1965.
