

# Mrs. Logan says hearing just a 'kangaroo court'

SALEM (UPI)—State Industrial Accident Commissioner Emily P. Logan cried "kangaroo court" Monday and refused to answer charges of "inefficiency in office" leveled at her by Gov. Mark Hatfield.

Mrs. Logan's attorney, Ernest Bonyhadi, questioned the legality of procedures followed by Hatfield, and said he had not yet decided whether to take the issue to the courts, or to answer the charges in a public statement.

Mrs. Logan and Commission Chairman Sidney B. Lewis received dismissal notices, effective today, on June 11.

Hatfield charged them both with "inefficiency in office," and set Monday's hearing in case either wanted to dispute the charges.

Lewis resigned Friday. A few hours later, Wilfred A. Jordan, Coos Bay Republican, was named to succeed him.

Hatfield named Grants Pass Mayor Charles B. Gill Jr., a Democrat, to succeed Mrs. Logan, effective today.

Mrs. Logan refused to resign. She arrived at the board of control room for Monday's hearing three minutes ahead of time.

Hatfield entered the room six minutes later.

**Room Overcrowded**  
Some 50 spectators—about half of them women—crowded into one end of the room. There were not enough chairs. Some stood, others sat on the floor. The crowd overflowed into the hallway outside.

Warne Nunn, Hatfield's executive assistant, read a five-page statement which declared "the functioning of the department has deteriorated... due in large part to the inefficiency of commissioner Logan."

The statement was critical of the management exercised by the commissioners. "The arbitrary manner of the commission has caused an extremely low staff morale which, through reduced productivity, has been costly."

The statement then included 11 sets of quotes from unidentified persons criticizing department morale.

"When the morale problem had been brought to the attention of the commissioners, they denied that a problem existed," the re-

## Forest Service timber sold

Two salvage area sales and one blowdown sale were made by the Deschutes National Forest in recent days.

On Monday, Ernest Price, Meltoits District ranger, conducted two sales, from his office in Sisters. One was in the Candle Creek salvage area, the other on Jack Creek. The Candle Creek sale holds some 200,000 board feet of yellow pine and about 50,000 board feet of Douglas fir and western larch. Minimum acceptable bid for the pine was set at \$12.85 per thousand feet.

The Jack Creek salvage area holds some 200,000 board feet of pine and 100,000 board feet of Douglas fir and western larch and 50,000 board feet of white fir and other species. Minimum bid for the pine was set at \$15.40 per thousand.

William R. Looney, Bend, obtained both the Jack Creek and the Candle Creek salvage timber at the minimum acceptable bid. On June 29 in the office of Fort Rock District Ranger Henry Tonsen the C and K firm was successful bidder for 150,000 board feet of blowdown pine in the Polyp blowdown area. Bidding against C & K (Virgil Carpenter and J. R. Keyes) was Clifford O. Smith, Bend. In the bidding, the price of pine increased from \$7.25 to \$7.50 per thousand.

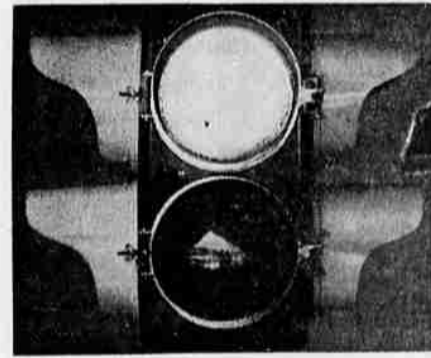

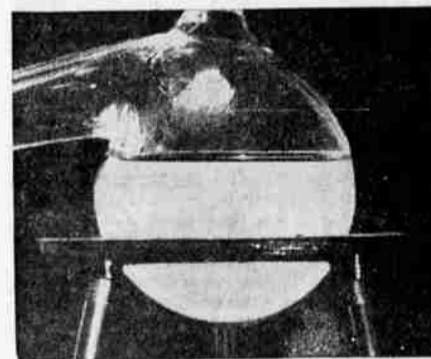

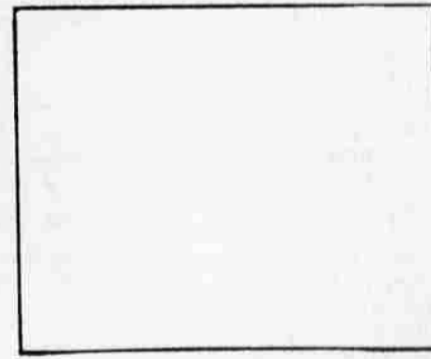
