Commission opens hearing on tax protests

SALEM (UPI)—Benton County timber owner Wilson Bump told the State Tax Commission today that his land was worth from \$1 to \$2 per acre after costs of reforestation had been deducted.

The statement came as the commission opened the first of a series of protest hearings on new forest land assessments in five northwestern Oregon counties.

The commission earlier this year generally doubled the assessed value of timber lands in Benton, Columbia, Lane, Linn and Washington counties. The new timber land values range from \$20 to \$40 per acre.

More Than 60 Attend
More than 60 timber owners were on hand for the opening-day hearing.

Tax commissioners said the hearings would continue all week. A final decision by the commission on whether the assessments will remain as set, or will be reduced, is expected to be made at the end of the week.

The Boards of Equalization in Benton, Columbia, and Lane counties lowered the commission values. The Washington and Linn county boards upheld them.

All three tax commissioners, Paul F. Lining, Fred Hoefke and Charles Mack, were on hand for today's session.

Costs Outlined
Bump spoke for more than an hour to outline the costs of replanting timber. He said it cost \$42.99 to replant "an acceptable acre."

When asked by the commission if he replanted all his land, Bump replied, "Definitely not. I stopped replanting when I figured I could not get a proper return on my investment."

Fred Sandoz, chairman of the Tax Committee of the Industrial Forestry Association, told the commission that land values had not gone up, and also questioned the commission's action in increasing the assessments.

Agencies to present UF appeals

Definite Law
The law directs the secretary of state "to place the names of candidates upon the ballot when he shall have determined in his sole discretion that such candidate's candidacy is generally advocated or recognized in national news media throughout the United States."

The only way a supposed candidate can duck the primary is to file an affidavit "stating without qualification that he is not now and does not intend to become a candidate."

Oregon to be center of spring political attention

SALEM, Ore. (UPI) — Oregon will be the center of national political attention next spring when candidates are announced for the state's presidential primary election.

Under Oregon's unique election law, the secretary of state has authority to place candidates' names on the presidential primary ballot.

The system is designed to throttle the ambitions of "favorite sons" and give the state's residents an opportunity to vote on the front runners in each party.

Presidential hopefuls can petition to have their names on the ballot. In addition, the secretary of state can arbitrarily add whomever he wants to the list of candidates.

Richard Nixon's name was placed on the Republican ballot by petition.

Three Nominated
On the Democratic side, Kennedy, Sen. Wayne Morse, D-Ore., and Sen. Hubert Humphrey, D-Minn., were nominated by petition. In addition, Appling added the names of Stuart Symington and Lyndon Johnson.

Oregon's primary election next year will be held May 15, well before the Republican and Democratic National Conventions.

While nobody expects a race on the Democratic side, the outcome of Oregon's Republican primary balloting could prove a disaster to some hopefuls.

Oregon's secretary of state, Republican Howell Appling Jr., refuses to speculate on the selection he will announce next March 6.

Informed sources believe that if Appling were faced with making the decision today he would name New York Gov. Nelson Rockefeller, Arizona Sen. Barry Goldwater, Michigan Gov. George Romney, and Pennsylvania Gov. William Scranton on the Republican ballot.

It now appears that only President Kennedy will be on the Democratic ballot.

In 1960, Appling announced he would place Rockefeller and Adlai Stevenson on the primary ballot. Both immediately withdrew their names.

Richard Nixon's name was placed on the Republican ballot by petition.

On the Democratic side, Kennedy, Sen. Wayne Morse, D-Ore., and Sen. Hubert Humphrey, D-Minn., were nominated by petition. In addition, Appling added the names of Stuart Symington and Lyndon Johnson.

Oregon's primary election next year will be held May 15, well before the Republican and Democratic National Conventions.

Oregon's Gov. Mark Hatfield, a Republican, has been mentioned as a vice presidential possibility.

Appling didn't list any vice presidential candidates on the primary ballot in 1960, and nobody expects him to do so this year.
