

Negotiator forecasts long shutdown

SEATTLE (UPI)—Lowry Wyatt, chief negotiator of the Big Six lumber companies, Tuesday forecast a long shutdown as the result of the labor dispute in the Pacific Northwest lumber industry.

Wyatt, a vice president for the Weyerhaeuser Timber Co., said the companies have submitted their final offer to the two unions involved in the dispute which has killed more than 24,700 workers in Washington, Oregon, Northern California and Montana.

Wyatt, in Seattle for a news conference, said the companies simply could not meet the demands of the Lumber and Sawmill Workers union and the International Woodworkers of America. Wyatt forecast a short supply and higher prices for lumber and plywood unless there is a sudden change in demands by the unions. The industry offer made in a long session at Portland Monday included a 25-cent hourly wage increase during the next three years. The unions were reported to have asked for a 35-cent hourly boost.

No further meetings are scheduled between the union representatives and the Big Six, which includes U.S. Plywood, Crown Zellerbach, Weyerhaeuser, St. Regis Paper, International Paper and Rayonier.

Demurrer filed to Jeannace Freeman appeal

SALEM (UPI)—A demurrer to the appeal of convicted child slayer Jeannace June Freeman was filed Tuesday in Marion County Circuit Court.

The demurrer questions if there is sufficient legal evidence to warrant a post-conviction trial of the murder case. It was filed by Assistant Atty. Gen. Collis Marsters.

Miss Freeman had been scheduled to become the first woman to die in Oregon's gas chamber, but her Aug. 1 execution date was stayed when her attorneys filed the post-conviction suit.

If Marion County Circuit Judge George Jones sustains the demurrer the post-conviction case would be dismissed.

Should the demurrer be turned down, arguments on the post-conviction appeal would be heard later.

Post-conviction proceedings were instituted in Oregon to provide a hearing for convicts who claim they haven't been given a fair trial or that their legal rights have been abused.

PRATO, Italy (UPI) — A violent earthquake centered somewhere in the Atlantic Ocean off the coast of Greenland erupted at 2:32 p.m. (EDT) Tuesday, according to the Seismological Observatory here.

A spokesman said instruments recorded a shock of seven or eight degrees on the Mercalli scale. The center apparently was located 1,600 miles northwest of here, he said.
