

## Student group members worry about future

MADRID (UPI) — A group of 54 American students who defied a government ban on travel to Cuba today were reported worried about the effect the trip will have on their future.

Several have refused to give their names or home towns to reporters on the ground they might face dismissal from colleges or be barred from enrolling.

They were expected to fly to New York Thursday and face removal of passports by the State Department and possible prosecution for violation of the Cuba travel ban. Maximum penalties are five years in prison and a \$5,000 fine.

Some of the group, which flew into Madrid Monday night, talked glowingly of the seven-week tour of the Caribbean island. The group was invited by the Cuban Student Federation and the Cubans paid the expenses.

One member of the group, Clinton M. Jenks of Monroe, La., said Tuesday the trip disillusioned him about Cuba under Premier Fidel Castro.

"I don't know how they lived before in Cuba," he said, "but I am sure the people of Cuba never lived worse than they do now."

"They told us the people were better off now but I don't believe it."

The 20-year-old drama student made the trip with his wife Clara. He grew a beard during the trip but had it shaved off here Tuesday.

Other youths, who declined to give their names, said "Cuba was great. Castro has given his people much better living conditions than before."

Richard Thorne of Berkeley, Calif., said the group traveled all over Cuba. "What impressed me was the thousands of schools," he said. "Castro is certainly trying to educate the people."

Robert Kafka of San Francisco said the State Department ban on travel to Cuba and Communist China didn't worry him.

One member of the group, Christian Lee Rainsner, 23, of San Francisco, was arrested by Spanish police on arrival because he had no passport, but was released Tuesday night when the U. S. Embassy intervened. Rainsner said he lost his passport in Cuba last week.

## Circuit rider back in Salem

SALEM (UPI) — The circuit rider statue was back atop its pedestal in the Capitol Park today.

But the job didn't exactly go according to schedule.

The 3½-ton bronze statue was severely damaged during last year's Columbus Day storm, and was taken to Vancouver, Wash., for repairs.

The return trip to Salem was uneventful.

The statue arrived in Salem at 1:45 p.m. Tuesday and workmen had it on its marble pedestal 30 minutes later.

That's when it was discovered that the new stainless steel mounting bolts were a half an inch short.

The statue had to be removed, and a welder was called to extend the bolts.

It took an hour to get the job done, and at 3:30 p.m. the statue was again hoisted atop the pedestal and quickly bolted in place.

While the trip to Salem was uneventful, it was not without worries for the workmen involved. A special low-bed trailer was used, and the huge statue made its way under freeway overpasses with little more than an inch to spare.

About 50 tourists and state employees were on hand to watch the statue being replaced.

## Viet Nam military leaders accept raid responsibility

SAIGON, South Viet Nam (UPI) — South Vietnamese military leaders, whose forces are supported by American aid, put themselves in direct conflict with the United States today with their acceptance of full responsibility for the recent raids on Buddhist pagodas.

The military chiefs said they, and not Ngo Dinh Nhu, initiated the crackdown which resulted in the arrest of thousands of Buddhist leaders and the imposition of martial law throughout this Communist-threatened country.

The statement issued Tuesday night by the entire joint general staff headquarters of the Vietnamese army was interpreted as a slap at the U. S. State Department and was certain to cloud U.S.-Vietnamese relations still further.

The State Department had said in a statement that the army leaders had not been forewarned of the Vietnamese government's plans to arrest Buddhist monks and attack pagodas to crush opposition to the administration.

It had been reported reliably that Nhu, brother of President Ngo Dinh Diem, had engineered the crackdown on the Buddhists last Wednesday and quietly took power in a palace coup.

## Union Pacific running trains on schedule

PORTLAND (UPI) — A Union Pacific Railroad spokesman said the line planned to run all trains as scheduled today in the face of a possible nationwide rail strike.

The decision would be altered if Congress failed to pass a bill to refer the issues of the dispute to an arbitration board for a binding decision.

Congressional leaders promised action of the Senate-passed bill before the 12:01 a.m. Thursday deadline.

UP posted notices today to non-operating employees which stated their positions would be temporarily suspended in the event of a strike after the close of the shift tonight. This would affect 75 per cent of its employees, a spokesman said. Union Pacific has 3,591 employees in Oregon, 1,876 in Portland.

The Senate approved the measure for arbitration Tuesday night by a vote of 90 to 2. Sens. Wayne Morse, D-Ore., and John Tower, R-Tex., voted against it.

## Suspect in killing of two policemen shot to death

NEW YORK (UPI) — One of two men wanted in the killing of two New Jersey policemen was shot to death today in a violent struggle with detectives in a midtown Manhattan hotel room.

The dead man, Frank Falco, 23, had been sought since early Monday when the two officers were forced to disrobe and then were shot to death in the Angel Lounge, a nightclub in Lodi, N.J.

Quinn said he took out his gun, placed it against Falco's throat and ordered the suspect to get up. He said Falco woke up screaming, grabbed the detective's gun and a hand-to-hand battle followed during which six shots were fired.

Quinn said both he and Falco were holding on to his revolver during the struggle. The officer said he emptied his gun.

"I don't know how many times I shot him. I was mainly interested in holding on to my gun," Quinn said.

Seconds later four other detectives raced into the room and one of them shot three times at the suspect. Falco fell dead on the floor.

Decision due on air service

SPOKANE (UPI) — The initial decision in the Spokane area air service case is expected from Thomas L. Wrenn, Civil Aeronautics Board examiner, sometime next month.

The case involves the mandatory stop at Pendleton, Ore., by United Air Lines.

George Shoemaker, Spokane attorney, said he had received no official indication when the decision would be announced, but if Wrenn follows his usual timetable it should be ready in September. Shoemaker represents local interests in efforts to have the so-called Pendleton restriction lifted.

VANCOUVER, Wash. (UPI) — Sen. Thurston B. Morton, R-Ky., chairman of the Republican Senatorial Campaign Committee and former national party chairman, has agreed to address a \$25-dollar-a-plate fund-raising dinner here Nov. 14.

## Congress seeks to carry on its business despite Negro march

WASHINGTON (UPI) — Congress sought to carry on business as usual today although members' attention was diverted by varying degrees to the civil rights march on Washington.

The House took up emergency rails legislation Tuesday night by the Senate to forestall a nationwide train strike threatened for Thursday. House leaders foresaw no major snag toward enactment of the arbitration bill before the midnight deadline.

House Democratic leaders arranged for members to take a 10 day Labor Day recess.

Speaker John W. McCormack said if the House could finish work on pending railroad and space bills today there would be no further business on the floor until the week of Sept. 8.

SUIT FILED

PORTLAND (UPI) — A Toledo, Ore., couple filed a \$90,000 suit against the Georgia-Pacific Corp. in Circuit Court here Tuesday.

Mr. and Mrs. Lawrence E. Davis charged in the suit that operation of the firm's pulp and paper mill at Toledo has resulted in damage to their home.

They asked to be awarded \$40,000 from the company for alleged deprivation of use and enjoyment of their home and \$50,000 in punitive damages.

Other congressional news: Shelters: The rules committee cleared for House action legislation calling for a start on a fall-out shelter construction program.
