

Harvest Days promotion set by merchants

Harvest days are here and the 1963 Thanksgiving - Christmas season is rapidly approaching.

Retail merchants of the Bend Chamber of Commerce took cognizance of this fact at a meeting Monday when they set dates for their annual Harvest Days, to be observed on October 25 and 26, and decided on a date for the official start of the Christmas season.

Thanksgiving Day this year will fall on November 28, later than usual. The official opening of the Christmas season will be on Friday, November 29.

On November 29, all Christmas decorations will be in place on downtown streets, and yule lights will be turned on as the season starts. The lighting will be the occasion of a special program.

The retail merchants decided that beginning on December 16, stores will remain open until 9 p.m., each weekday evening, including Monday, December 23. Stores will be open every Friday night as usual in advance of and through the yule season.

The retail merchants, headed by Bob Somerville, received further reports relative to the recent highly successful chicken barbecue and agreed that it should be made an annual event. Nearly 3,000 persons attended the 1963 barbecue, with chickens prepared on outdoor grilles under the supervision of Bernico Coombs. Ken Brown was chairman of the barbecue.

Plans for Harvest Days on October 25 and 26 are already taking final shape. Permission will be sought to rope off a section of Wall Street between Franklin and Minnesota for a program October 25.

A display of new cars will be a feature of the Harvest Days program.

Murder suspect taken following 5-week quest

SPOKANE (UPI)—A warrant charging John Henault, 18, Hyannis, Mass., with first-degree murder in the shooting death of a young Spokane service station attendant Aug. 25 was signed in Justice Court here Monday by Judge Gordon S. Lower.

The five-week search for the slayer of 16-year-old William H. Matthews ended Monday with the arrest of Henault in Hyannis. He pleaded innocent Monday to a fugitive from justice charge and was ordered held without bail by Barnstable District Court Judge Henry L. Murphy. The case was continued until Wednesday.

Henault was also charged in the Spokane warrant with the robbery of the service station where Matthews had worked for about a month.

Spokane police said a piece of the trigger guard of a .22 caliber revolver which had been found at the scene and the honesty of the youth's father in paying his son's debts led to Henault's arrest. Police Detective Al Wasser continued a search for the murder weapon late Monday in Stevens County north of here, where Henault told police he had discarded the weapon.

Wasser said detectives checked nearly 150 agencies which handled the type of weapon used in the slaying before they learned a revolver of that type had been purchased at Coeur d'Alene, Idaho, east of here.

Two weeks later the youth's father sent money to the hotel where Henault had stayed to cover a bad check and the hotel, after Henault had left town the morning of the killing without paying his bill.

That set police on his trail and eventually led to his arrest.

Change in judge being sought

PORTLAND (UPI)—A motion has been filed in Federal Court here asking for another judge to decide a tangled title dispute involving the Pilot Butte Inn at Bend.

The motion was filed by Bend attorney Charles E. Boardman on behalf of Dickerson, Inc., and Mr. and Mrs. Arthur Sirett, Vancouver, Wash., who contend they are entitled to be reimbursed about \$129,000 they said was advanced to William Corbett, one of the disputed owners.

Boardman said that in asking for a judge other than William G. East his intent was neither to set aside a restraining order nor to change any decisions in past rulings. The restraining order prevented action affecting the present status or title.

Boardman indicated legal effectiveness of a U.S. marshal's sale in July was an issue still pending.

ALBANY, N.Y. (UPI) — Gov. Nelson A. Rockefeller, a potential 1964 Republican presidential candidate, renews Friday the political atmosphere Friday and Saturday with visits to Indiana and Oregon.

A tentative itinerary, announced by his office here, shows the governor will arrive at the Louisville, Ky., airport and at 9:30 a.m. go by car to French Lick, Ind.

The New York governor will attend a private luncheon in French Lick Friday.

Later he attends a luncheon given by the annual convention of the Indiana Bar Association.

The governor flies from Louisville to Eugene, Ore., airport and will spend the night at the Village Green motel, Cottage Grove.

Rockefeller has scheduled a 9:30 a.m. news conference at the Eugene Hotel for Saturday morning. Later he will attend a University of Oregon reception and attend a box luncheon at the Republican western conference, McArthur Court.

Rockefeller will attend the Oregon-Idaho football game at 1:30 p.m.

He is scheduled to speak at the conference at 12:15 p.m.

He is scheduled to leave Oregon about 3:30 p.m. This would be half an hour before the arrival in Eugene of Arizona Sen. Barry Goldwater, who also is to address the GOP meeting.

Sen. Neuberger claims DAR has aimed venomous drive at her

WASHINGTON (UPI) — Sen. Maurice B. Neuberger, D-Ore., said today she had been subjected to a campaign of "concocted venom" for suggesting withdrawal of tax exemption for the Daughters of the American Revolution (DAR).

In a speech prepared for Senate delivery, Mrs. Neuberger said she had been attacked with the implication that she was "a Communist, a party to the 'international anti-freedom conspiracy.'"

The implication that she was a Communist, she said, was made on Life Line, a program sponsored by Texas multimillionaire H. L. Hunt.

Mrs. Neuberger said the attack was begun after she urged Internal Revenue Service Director Mortimer Caplin to withdraw tax-exempt status for the DAR.

Cites 1934 Law

The Oregon Democrat said tax exemption for the DAR violated a 1934 law which prohibits such exemption to organizations "carrying on propaganda."

"It does not, I take it, constitute treason," she said of her insistence that the law be applied to the DAR.

Mrs. Neuberger said Life Line "treads a careful path of innuendo, implication, and false analogy" in attacking her, but had left it to individual letter writers "to fill in the blank spaces."

Letters which Mrs. Neuberger cited included one from a "public-spirited citizen" who wrote: "You Jews run true to form. You attack everything American—along with the Communists—to promote the destruction of America and the final takeover.

"You don't like the DAR because you could never be eligible. Your ancestors probably got here about 1900, after the Christians built this country."

Modeled Swim Suit

Mrs. Neuberger, who as a senator's wife once shocked the capital's more sensitive souls by modeling a bathing suit before press photographers, also cited a letter from a woman in Grosse Pointe, Mich., who wrote: "Believe me, you look mighty small in the press, and smaller still to those who once thought you a gentleman."

Mrs. Neuberger said some of the attacks might be the result of a misunderstanding of her views. In seeking to clarify her stand, Mrs. Neuberger noted that the

Various agencies, including the Governor's Committee on Employment of the Handicapped, are cooperating in a joint public education program to rehabilitate and hire the handicapped.

As observance of the week got under way here, the Worker's Committee in Bend gave special recognition to Mel Rogers, one of the members, "for his outstanding leadership in hiring the handicapped."
