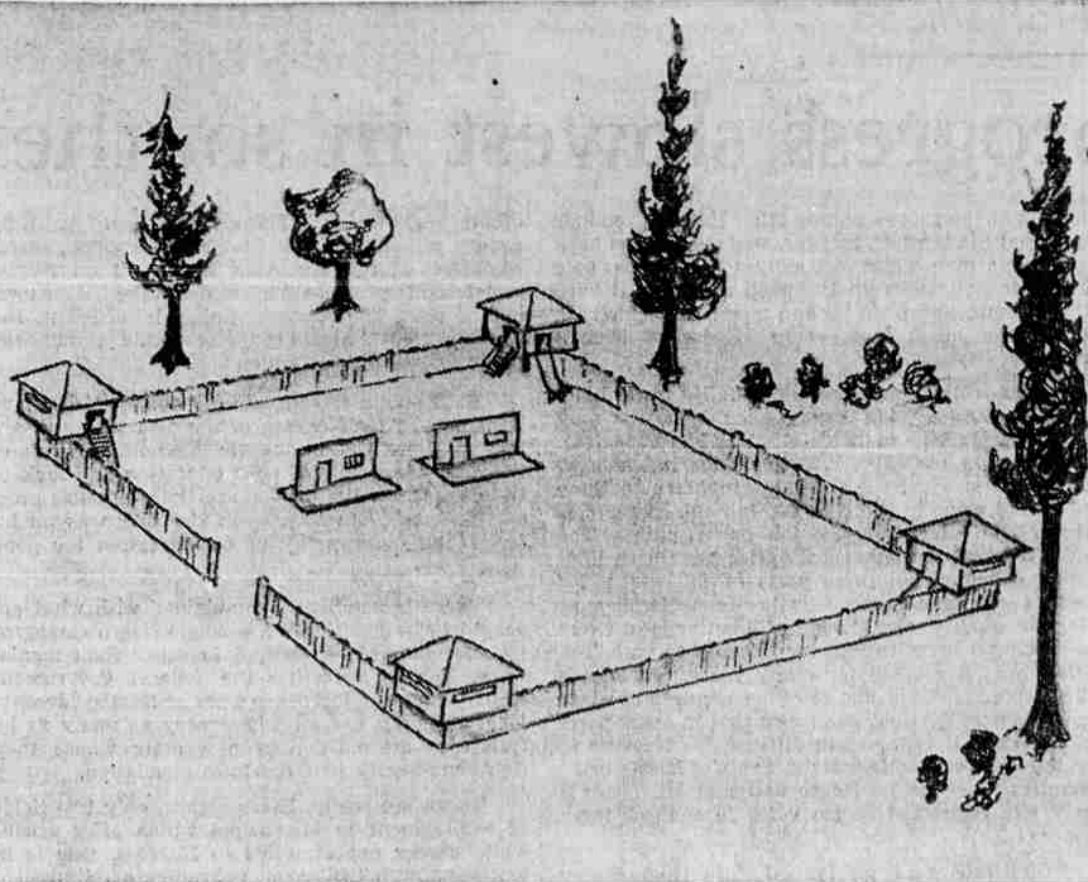

### New debt limit asked by Dillon

**WASHINGTON (UPI)**—Treasury Secretary Douglas Dillon today asked Congress to approve a temporary national debt limit of \$315 billion for the last seven months of this fiscal year. This would be \$6 billion above the ceiling authorized through November.

Dillon also told the House Ways & Means Committee that he now expects the U.S. budget deficit for this fiscal year will be \$9 billion, substantially less than the \$11.9 billion deficit predicted earlier this year.

The current temporary debt limit of \$309 billion is scheduled to expire Nov. 30. Unless Congress acted, the debt ceiling would revert to its permanent level of \$285 billion, far below present levels.

### Cook lashes out at Sen. Musa

**TILLAMOOK (UPI)**—State Sen. Vernon Cook, D-Gresham, has renewed his demand that the entire legislature decide where to make budget cuts as a result of voter rejection of a tax increase Oct. 15.

Cook lashed out at Senate President Ben Musa, D-The Dalles, Monday night in a speech to the Tillamook County Democratic Central Committee.

Noting that Musa had proposed that the 14 members of the Ways and Means Committee meet with the State Department of Finance and Administration to agree on cuts, Cook commented, "The members of the Oregon Legislature were not elected to rubber stamp the decisions of Governor Hatfield. Nor were we elected to delegate our responsibilities to less than one-sixth of the members of the legislature."

"It is a shocking thing to have the Democratic president of Oregon's Senate propose that budget cuts...should be determined by the governor's Department of Finance," he said.

"To direct the Ways and Means Committee to examine the budget in one week is like sending 13 men and one woman to put out the fires in the Tillamook Burn," Cook said.

### Bartsch named lab director

**CORVALLIS (UPI)**—Dr. Alfred F. Bartsch, a specialist in aquatic biology, has been appointed director of research for the new Pacific Northwest Water Laboratory at Oregon State University.

The appointment was made by Assistant Surgeon General Gordon E. McCallum, the chief of the U.S. Public Health Service's division of water supply and pollution control.

The Corvallis laboratory will be completed in 1965.

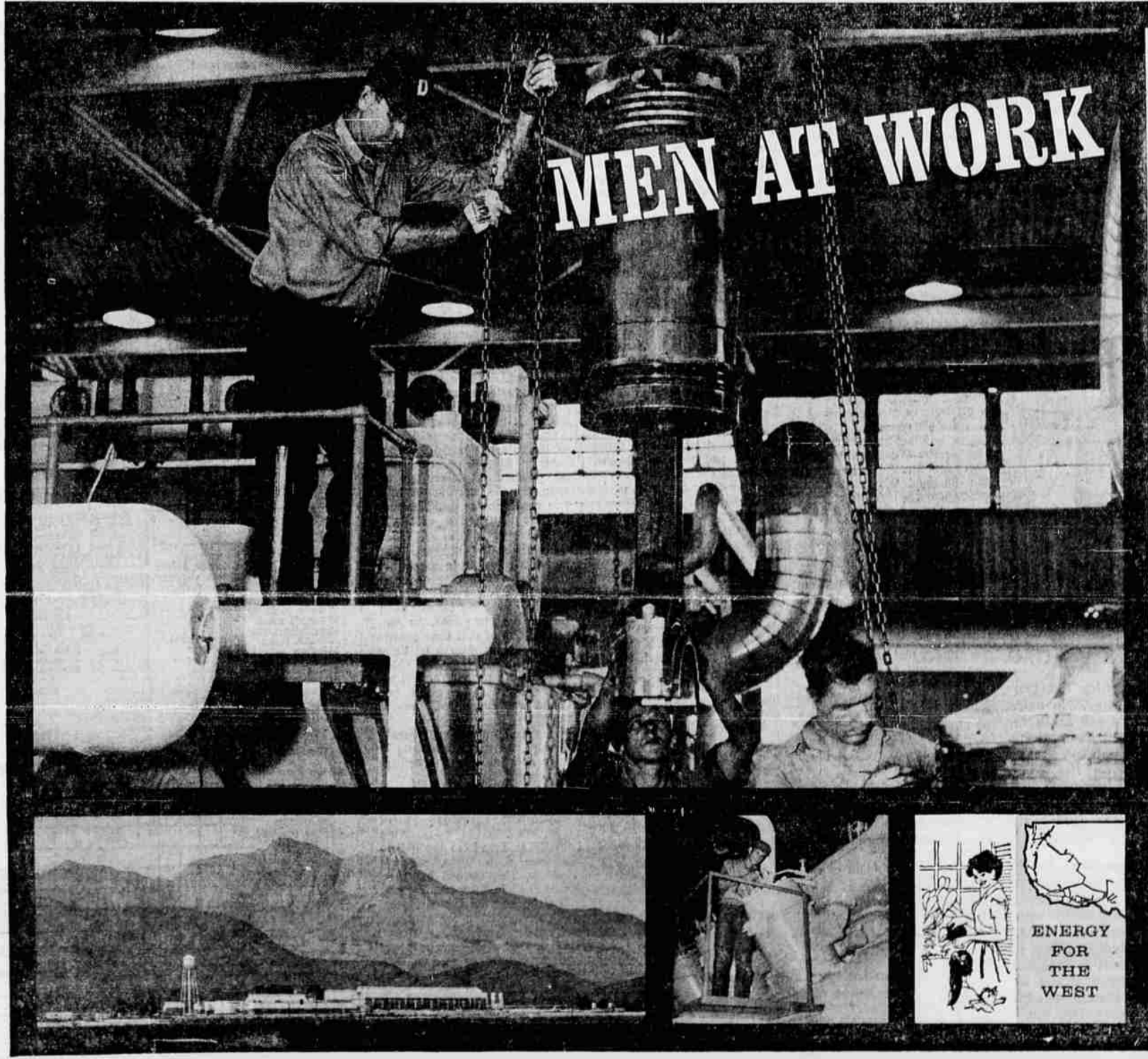
