SUMMARY: Voters approved formation of La Pine Park & Recreation District to provide the community with park, recreation, and cultural enrichment experiences. The District's tax base, approved in 2009, is 30 cents per \$1,000 assessed value. The proposed levy of 27 cents would supplement the tax base for a period of 5 years, commencing in November, 2021.
