Taxes in Baker. Property owners in Baker county will get off this year with a tax of only 46.3 mills on the dollar. Besides the county and state tax, amounting to 28.8 mills, the city and school district taxes are 17.5. Such a rate of taxation is not confiscation, but it is at least a second cousin. Baker cannot expect to progress very rapidly from the investment of outside capital within its limits so long as such taxation prevails.—Dalles Times-Mountaineer.
