A part of the big printing plant for this office has arrived and Joe Smith has taken full charge of the press room, torn out the floor and it putting down a solid stone and brick floor. He is to blame for any deficiencies in this issue, as he has crowded us up into one corner and misplaced everything he could get his hands on. The Times-Herald will certainly be a "solid institution" when Joe finishes laying a floor of F. L. Wiseman's best red brick. The teams are expected with the rest of the plant the latter part of next week and when in place Burns will have the most up to date and best equipped printing office of any interior town in the Northwest. The Times-Herald will be turning out a daily just as soon as our city becomes metropolitan enough to justify it.

Oregon's representatives to the National Irrigation Congress recently held in Colorado Springs endeavored to impress upon that body the fact that Oregon had the largest forest reserve; southeastern Oregon is the largest section of the United States without railroad, and that Oregon has paid into the U. S. treasury \$211,000 of the \$8,000,000 now on hand for reclamation of arid land. The recent irrigation act provides for the expenditure of funds arising from the sale of public lands within each state for the benefit of arid lands within the limits of such state. Such being the case, Oregon has a considerable to her credit and will likely realize something in the line of irrigation in a short time.

When our neighbors get things so badly twisted, we cannot wonder that by the time news reaches the Portland papers that it is exaggerated and bears no semblance of the truth. The Blue Mountain Eagle of last week published a report of the range trouble near Trout creek that was far from true. C. F. McKinney was not near the scene of the shooting nor were horses shot from under any one.

### FROM SENATOR MITCHELL.

U. S. Senator Mitchell writes Hon. A. W. Gowen, under date of Oct. 12, as follows:

"My dear Friend Gowen:—On my arrival here this morning, returning from Hawaii, I find yours of October 5th awaiting me, in which you enclose petitions numerous signed, addressed to the President of the United States, protesting against the proposed forest reserve, known as the Blue Mountain Forest Reserve, with reference to its extending further south than the third standard parallel township line, between townships 15 and 16 south of the Base Line; and in which it is stated that in all the territory south of said line, which it is now proposed to be included in said reserve, there is no marketable timber, or very little suitable for manufacturing into marketable lumber; and further that all of such territory south of said line is absolutely necessary for the use of settlers now living in and developing Harney valley and vicinity.

"I have today forwarded these petitions to the President of the United States and have asked for them the careful consideration of himself, the Secretary of the Interior and the Commissioner of the General Land Office.
