DOES IT MEAN GOVERNMENT WORKS?

Last Tuesday the local land office was notified by telegram from Washington to withdraw township 18 19 and 20 in Silvies valley from entry.

There is considerable significance attached to this move, as it is evident the land is withdrawn pending an investigation of the big irrigation project which was recently inspected by Engineer Whistler.

The possibilities of the Silvies valley project have never been brought to the attention of the general public and therefore its magnitude not realized.

It is known to the government that with a 20 foot cut the middle fork of the Malheur River can be brought across Logan valley and emptied into Silvies River in Bear valley, thereby greatly increasing the volume of water.

While it was a new departure for the grand jury in its report last week to mention the livestock interests in Harney county, it was, nevertheless, timely and right.

SMALL-POX.

In connection with the present uneasiness about small-pox it might be well to call attention to the recent utterances of the officers of the State Board of Health.

"The sole weapon which has enabled the authorities to successfully cope with and limit the epidemic has been vaccination. Hence the following conclusions reached on the basis of hundreds of thousands of cases are plainly confirmed by the experience of this epidemic.

"This is peculiarly gratifying, as the discouraging fact states the medical profession in the face, that after 2000 years of experience with this disease absolutely no remedy, drug or agency, is known that has the slightest effect upon its course.

"With this weapon smallpox has now been practically exterminated in civilized regions. Practically exterminated by reducing the death rate to one or two in the million, whereas up to 75 years ago in England and on the Continent about one person in three was marked with its scars.

In yesterday's Oregonian Dr. A. C. Smith, President of the State Board, gave out the following:

"The combined resources of a trained nurse and a skillful physician are needed in such cases of smallpox as are occurring in Prineville. There is no specific treatment for smallpox. It is a disease that must be treated according to the symptoms, and takes the closest attention of the physician.

"As to the treatment of the disease" said the doctor, "perhaps the most essential thing is absolute cleanliness, especially when eruption appears. Many deaths in smallpox are due to external infection on account of the lack of cleanliness.

"Despite the popular notion to contrary, it is safe to give the patient cold water to drink, and cold water sponges in the case of high fever are both a benefit and a relief."

In view of the fact that Health Boards everywhere regard vaccination as of paramount value as limiting as well as mitigating the disease, and that without it the strictest quarantine is practically of no avail, it behooves our citizens to see to it that they are fully protected in this respect.

If every resident of this county could be successfully vaccinated in advance of the appearance of the epidemic here, we would have little to fear.

The local health officers stand ready to do everything necessary to protect the community, but they cannot act properly without authority from the State Board of Health with whom they are in telephonic communication as to the advisability of a quarantine.
