## THE VETO WAS NO BLUFF

### GOVERNOR DETERMINED ON THE APPROPRIATION BILL.

#### Movement to Demand Referendum Begun in Yamhill County—Circulate Petitions On The Measure.

From sources that seem to be authoritative, it has been declared that the referendum will be demanded upon the \$1,000,000 appropriation bill passed by the last legislature, says a Salem special to the Oregonian. Men who are acting in the matter are not ready to publicly declare their intention, but they are securing referendum petition blanks and say that the people shall vote upon this omnibus bill for the expenditure of money. It is understood that the movement has its origin in Yamhill county and that a public meeting will be held for the purpose of taking the first step in circulating petitions.

The bill carries appropriations for the asylum, penitentiary, mute, blind and reform schools, the State University, Agriculture College, four normal schools and a few minor purposes. This is the measure from which Governor Chamberlain compelled the legislature to remove the emergency clause in order that the people may demand the referendum if they so desire. This privilege having been secured to them, it now seems that the people will pass upon the merits of the appropriations.

Many members of the legislature thought Governor Chamberlain was "bluffing" when he told members of each house that he would veto the appropriation bill if it came to him in the form it passed the lower House, but most of them gave up that idea when he sent his formal message to the Senate last Friday afternoon plainly and unqualifiedly announcing his determination. If any are still in doubt about what the Governor intended to do, they will perhaps be surprised to learn of the steps the governor had taken to defeat the appropriation bill as it was drawn.

Early Friday morning, the last day of the session, the Governor prepared a veto message, giving his disapproval to the appropriation bill which had not yet passed, and also prepared a proclamation calling a special session of the legislature for Monday morning, February 20. His determination was that if the bill should be passed carrying an emergency clause, he would immediately file the veto and serve every member of the legislature with a copy of the call of a special session before any member could get out of town. The moment the legislature adjourned the proclamation would have gone out and an officer would have been at each train to serve members about to leave.

Had the legislature not yielded to the Governor's views, the legislature would have been in session in Salem this week. The emergency clause having been stricken out, the appropriation bill is subject to the will of the people, and the Governor withheld his veto.

#### Sumpter V. Ry. Build This Year.

#### Lewis and Clark Guards.

In a communication addressed to Major Chas. E. McDonnell, of the Oregon National Guard, Director-General H. W. Goode, of the Lewis and Clark World's Fair, has officially announced the plans for the guard and patrol of the exposition.

The guard will be recruited among the men of Oregon's National Guard, and will consist of two provisional companies as follows:

One major, two captains, two lieutenants, one first sergeant, one quartermaster sergeant, one duty sergeant, three corporals, two musicians, 150 privates and two cooks. A blouse of dark blue with light facings and aquillette of the same color, light blue trousers, ball shaped caps with full dress band, web belt, bayonet and scabbard, white collar, with gloves and black shoes, have been selected as the uniform and equipment.

## PUBLIC LAND LAW REVISION

### PRESIDENT RECEIVES HENEY'S VIEWS OF CHANGES.

#### District Attorney Regarded as Authority on This Subject—Recommendations of Commission Unsatisfactory.

It is believed that a goodly portion of the future conferences between President Roosevelt and Francis J. Heney will be devoted to a careful consideration of proposed new laws governing the disposition of the public domain, and framed in accordance with the present and prospective needs of the country. Heney is regarded as an authority upon this subject, and probably no man is better qualified to pass judgment upon such measures. He has lived all his life in the west, under circumstances that have brought him in constant contact with almost every condition affecting the public land question.

Much of his time was passed in Arizona where the mining laws and desert land acts received their full measure of consideration. In California he was afforded the opportunity of studying every feature of the homestead and timber land laws, besides the various acts relating to the state-land indemnity system, together with the principle of adjustment outlined by the forest reserve Act of June 4, 1897.

Nobody doubts that here in Oregon he has had excellent chances to learn a great deal more pertaining to the matter—in fact, made a general clean-up and become posted upon about every other known method of acquiring title to Government lands. In addition to all this he is a keen observer, and eminently qualified to render material aid in framing new laws.

It is reasonably certain that the chief Executive is not satisfied with the recommendations of the commission appointed a few years ago to revise the public land laws. It is probable Mr. Roosevelt may adopt the ideas of one who is perfectly familiar with every detail of the question, coupled with his own personal knowledge of affairs of this character, as the President was at one time a resident of a western state, and became more or less acquainted with the conditions prevailing in a country where the public land laws cut such an important figure.

Heney has already demonstrated an aptitude for framing laws upon land matters, and only a short time ago, in response to a request from Governor Pardee, of California, drafted several measures that no doubt will be adopted by the Legislature of that State, and which experts upon the subjects say fulfill every requirement of the situation.—Telegram.

### FOURTEEN HORSES SENT BY THE KANAGWA MARU ON THE TRIP TO THE ORIENT.

The compartments in which the animals were confined while enroute were padded against accident by heavy seas, and plenty of hay and oats were served.

The Japanese agent in this country have been buying up all the horses they could get hold of and preparations are now being made for wholesale shipping.
