The exceedingly dry spring, caused by lack of snow fall in the mountains last winter, is working a hardship on stockmen all over the Northwest. It is reported that fully 75,000 head of Idaho sheep have been brought into Malheur county and that sheep are now as high up on Stein's Mountain as they are the first of July in ordinary seasons. Stockmen hope for rain in a short time as that will relieve the situation.

## COUNTY COURT

Very little of record has been transacted by the present session of county court. Considerable road matter has been under consideration but few orders have been "made" or journal entries written.

The L. S. Tyler road has been ordered abandoned.

Aliquor license was granted to M. Morton of Diamond for six months.

The road from Windy Point to Flag springs petitioned for by A. E. Brown and others was ordered surveyed.

The road formerly petitioned for from the vicinity of Alva Springer's to intersect the county road at Windy Point was ordered opened.

Petition of Fred Denstedt and others for the opening of a road 3 miles in length to run north and intersect with the Harney road was favorably considered and ordered opened.

Two changes in roads in the vicinity of Harney were ordered placing them on section lines and straightening out the roads.

## AN IMPROVED MAIL SERVICE

The Sumpter Valley Railway has changed its schedule and now leaves Baker City at 9:15 a. m. making close connections with the east bound overland train of the O. R. & N. out of Portland, thus placing western mail into Burns by way of the Blue Mt. Rapid Transit Line about 24 hours earlier than formerly. That stage line now has the advantage of any other lines coming into Burns of 28 hours. Forty hours from Portland isn't so bad.

The Times-Herald suggested this change last January after the writer had returned from a trip to outside points over that line, and it is gratifying to see such a schedule in effect, as it is a great convenience to the people of this section.
