Propose Erecting a New Hospital.

Dr. D. E. Standard, recently of St. Louis, Mo., was an arrival in this city Wednesday evening and has decided to locate permanently. He will be joined shortly by his wife, who is also a doctor and Dr. Harlan A. Harris will be added to the firm later. The latter is now in the east where he will take extensive post graduate work.

According to Dr. Standard he and his wife were for years associated with some of the best hospitals in St. Louis and the lady has taken several post graduate courses in eye, ear, nose and throat work and makes that her specialty.

Dr. Standard has opened negotiations with parties in Burns for a property in which this new firm of Doctors contemplate starting a modern, well equipped hospital with a graduate trained nurse in charge. Such an institution would be welcomed in Burns and if properly handled by skilled professionals able to do work would be a most beneficial addition to the town.

Dr. Standard states he has spent the past twenty months looking over Washington, Idaho

and Oregon and says he feels confident there is to be a city of importance in the great opening empire of Central Oregon and he has picked Harney Valley as the location and Burns as the city.

Shipping 20,000 Cattle from California

Assistant Supt. Holland of the P. L. S. Co. informs The Times-Herald that his company is shipping some 20,000 head of cattle out of California on account of drought. The company has recently purchased some 10,000 head of steers, near the Mexican border and these were to be moved further north but since the dry weather in California it has been decided to ship twice as many.

The Oregon ranches of the company will accommodate 10,000 head and the balance of the shipment will go to the Nevada ranches and to eastern points where feed may be secured. The company used to grow or rather care for at least that number additional on the Oregon ranches and it is the intention to bring the number up to the maximum perhaps.

With cattle selling at the prices they are today it is fortunate that the big concerns are in a position to handle such big numbers to an advantage. By thus handling them they may be increased more rapidly and the present shortage relieved.

Harney County Wool Growers Meet a Success

The annual meeting of the Harney County Wool Growers Association was held in this place last Saturday afternoon and according to A. B. Whitney, who was elected secretary, it was a very successful one in which considerable enthusiasm was shown by those in attendance.

The new officers elected were: J. F. Mahon, president; O. E. Thompson, vice president; A. B. Whitney, secretary and treasurer. The executive committee appointed are Grant Thompson, P. C. Peterson and C. G. Smith.

The Times-Herald learns from Mr. Whitney that there was a good attendance and the members seemed to realize the importance of protecting their interest by organization. During the past year reductions in freight rates on wool has been secured and this was done by organizations of the character of the Harney County wool growers and this one accomplishment will result in saving thousands of dollars to the sheep men this season. The growers realize there are important problems and serious grievances confronting them and it is only by organization that the best interests of those engaged in the business can be safeguarded.

The sheep industry is a very important one in this section and represents many hundreds of thousands of dollars. The success of this great industry is of more than passing interest to the whole country and therefore the necessity of organization means much to the general public. Other industries of the entire nation protect their interests by mutual combinations therefore the local sheepman should see that it is his personal interest to foster such an organization as the one started here.

Growers who have not become members should join. If they desire any information it will be cheerfully given by addressing the secretary at Burns or any of the members. Mr. Whitney is one of the most enthusiastic members and his selection as secretary was indeed fortunate, as he will give the matter particular attention and do his utmost to make the association a success and see that its policies are carried out to the best interests of the members. This is true of the other officers of the association too, however, but Mr. Whitney is so situated and has the time to devote to his work that he will be found a valuable man to the association.

Quite a Snow Storm

Harney county seems to have received a little touch of the great storms that have been raging throughout the middle states. Last Wednesday morning we experienced one of the most disagreeable snow storms witnessed during the winter. It was of a short duration however, and the weather has moderated materially since. The snow fell very rapidly for a few hours and it was accompanied by a severe wind that made it drift. A similar storm was experienced here last year a little later.

It was fortunate the storm came thus early as the lambing season begins next week and such a storm during that period would entail a considerable loss to the sheep men. It is thought now they are comparatively safe.

A Sad Death

Mrs. W. M. Sutton, wife of Principal Sutton of the public school of this city, died at the family home last Wednesday evening at 9 o'clock. She had undergone a very serious abdominal operation last Saturday, Dr. Harrison removing eleven fibroid tumors. She rallied from the operation and it was thought she would recover but her death came five days after from acute dilatation of the stomach which affected the heart and her demise was quite sudden.

Deceased was formerly Miss Belle Lincoln and was born in Springfield, Mass. She was 44

years old. Married to Prof. Sutton in 1896 and both had taught in the schools of Springfield, Oregon, where they had lived since marriage.

A short funeral service was conducted at the home yesterday morning, before the body was shipped, by Dr. Babidge of the Presbyterian church. The many friends in this city extend sincere sympathy to the bereaved husband who expects to return immediately after interment at Cottage Grove and resume his duties in the school.
