

DELINQUENT TAX LIST 1918, HARNEY COUNTY, OREGON

The following list of real property situated in Harney County, State of Oregon, is hereby advertised for delinquent taxes for the year 1918. This advertising is authorized by an act embodied in Chapter 301 of the General Laws of Oregon as passed by the 1917 session of the Legislative Assembly.

The taxes on the following advertised list of real property became delinquent October 5, 1917, and are subject to a penalty of 5 per cent and interest at the rate of 12 per cent per annum until said taxes shall have been paid.

Notice is hereby given that six months after the taxes charged against the following real property first becomes delinquent the Sheriff as required by law will issue Certificate of Delinquency which will bear interest at the rate of 12 per cent per annum until the Certificates are redeemed.

Any time after the expiration of three years from the first date delinquent of any tax included in a certificate of Delinquency the holder of such certificate may cause summons to be served on the owner of the property described in the certificate, notifying the owner that he will apply to the circuit court of the county in which such property is situated for a decree foreclosing the lien against the property mentioned in such Certificate.
