Depuy-Sheriff Lockwood Assassinated while in Discharge of his Duty as Jailor.

The county court promptly offered a reward of \$1000 for the two men—\$500 apiece. The citizens offered an additional \$500, raising the reward to \$750 apiece, or \$1500.
