NEWSPAPER LAWS.

A postmaster is required to give notice by returning the paper does not answer the question whether or not he takes the paper the office, and the reason for its not being returned. Any neglect to do so makes the postmaster responsible to the publisher for payment of any person orders his paper stopped he must pay all arrears, or the publisher may continue to send it until payment is made. Any person who takes the paper from the publisher, whether directed to his name or not, or whether he has subscribed or not, is liable for the pay.

A subscriber orders his paper stopped at any time, and the publisher continues to send it, the publisher is liable for the postage on it of the postoffice. This proceeds against a man must pay for what he has received.

The courts have decided that refusing to pay for papers and not taking the paper leaving them uncollected for, without for the same, is prima facie evidence of an intent to defraud.

LATEST BY STAGE.

9,000 boot and shoe factory employees out of work in Bristol, England.

Receipt of corn in St. Louis, from Nov. 16th to Dec. 30th, is reported 2,000,000 bushels.

Russel Harrison is one of the directors in the great \$100,000,000 Catholic bank scheme.

Dec. 26, the consul at Victoria died suddenly, while spending his holidays with friends.

A lanta was in mourning Christmas Day for her great man, Henry W. Grady, who died on the 23d.

Wesley Fields was gored to death by a bull in Field's Hollow, above Waitsburg, Wash., 19th ult.

The murderer, James Eubanks, who so brutally ended the life of his daughter, Ada, is on trial in San Jose.

The English pugilist, Smith, and Australian Slavlin, had their fight in London, Dec. 23. The latter declared victor.

The Daily Examiner is demanding better service from the postmaster in charge of the San Francisco postoffice.

The new state of Washington has a big gold bug in their \$3,000,000 Senator Squire of Seattle, as Oregon has in Senator Mitchell.

School boys in Guatemala hanged their school teacher in the school room, one day last month, as per report of steamer Colima, Dec. 23.

At 5 o'clock, Dec. 22d, a disastrous cave in took place in the Utica mine, at Angel's camp, burying 16 men. No hope of getting any of them out alive.

Delivery clerk, J. Woodward, arrested at Denver, for taking a check for \$1,100 from an "immediate delivery" letter addressed to Henry Behn, a jeweler.

Niles O., Dec. 22d, reports Chas. Shelar, who has been drinking heavily for some time lately, as having cut the throats of his wife, three children, and himself.

Six men injured in a mob fight in the streets of Kansas City, Dec. 20; refusal of Pack Island Railroad contractor, McNeely, to pay his laborers, the cause of the trouble.

There were 100 prelates, 1000 priests and thousands of Catholic citizens in attendance on the late Catholic Congress, which fact is recited to show the unity of that church.

North Dakota prohibition bill was passed by a vote of from 23 to 8 in the State senate; passed the lower house and signed by the governor; goes into effect July 1, 1890.

The Old Year closed with the following report as to the country's general business affairs: Collections fair at Western points. Volume of trade continues larger than the year before. Railroad earnings show a handsome increase. Exports in November exceeded last year by 30,000,000; in December a shade smaller than last year. Treasury holds \$5,200,000 less than last year. Speculative markets comparatively dull. Business failures 342 against 311 last year.

M. P. Martin whose wife suicided last spring, to end her troubles, went to the house of Mrs. Isaac Taylor, near Cottage Grove, Lane county, during her husband's absence, and when making a criminal attack on that lady, she shot him dead. She at once surrendered herself to the nearest justice of the peace. On arrival at the house her statements were verified to the satisfaction of official investigation, and she was released. If every good woman were familiar with the use of a pistol, the brutal instincts of the worst class of men would be more effectually suppressed than under the present law.

Dec. 25th, George Jones, while protecting his sister from her husband, killed the latter, James Tracey.

The President of the new Brazilian republic is reported, Dec. 26, as having been in a dying condition, 21st ult.

Secretary Windom has decided to lease the Alaska seal fisheries to the Alaska Commercial Company, which made the lowest bid.

A telegram, Dec. 25, from Kansas City says Jesse James' slayer, Bob Ford, came within an inch of his life the evening before, while in a gambling room.

On Christmas day riot occurred near Savannah, Ga., resulting in the killing of two white men and several negroes, and calling out of militia, with trouble ahead.

Dec. 19th, the Laramie Plains Land & Cattle Co. made assignment in Laramie, Wyo. Their ranch of 17,000 acres, improvements and cattle were valued at \$126,000.

In a drunken quarrel a painter, Henry Armstrong, was killed, at his home on the Old San Jose road. His step-daughter and her husband, Sarah and Edward Conor, are under arrest for the crime.

"Every industry in the land appears to be falling into the hands of so-called 'trusts,' or combinations, which have for their objects the restriction of competition, and increase of the selling price of production."

Speaker Reed's evident partiality in recognizing republican friends for the introduction of bills privately, was too bare-faced to please even a few Republicans who voted with the Democrats for the credit of their party.

Judge Brewer is on the side of the rich Pullman Car Company in its legal war against the State of Kansas, wherein 75 counties allege the Company owe back taxes for three or four years. The case is now pending in the Supreme court.

The Big British Scandal is being carefully sifted so as to give evidence strong enough to punish editors that told of "titled persons" connected with it, a commoner named Newton for helping Hammond and other untitled men out of the country. The Prince of Wales is ferreting it out vigorously to save Prince Albert Victor's good name. He can learn the truth, but will the people? Not likely.

Congressman Randall's malady is cancer. The sweet tobacco spray in the dim and distant future, will be so suggestive of the horrid eating cancer, it will give men the jimjams to see it. Don't be alarmed, boys, it's only slaughtering men of prominence like Grant, Hill, Randall, and that ilk, at present. They are beacon lights set on the hill to warn passers-by—the blind cannot see them.

To cement in close commercial union the States of North and South America, an international project is on the tapis to construct a railway line from the shores of Columbia on the Caribbean sea, down through the heart of South America, to Buenos Ayres on the Atlantic coast, and to Iquique on the Pacific coast. May-trader can go from New York to Buenos Ayres in ten days. Costs money to build the road? Certainly, and as Blaine is excited over the scheme, through it the Republicans can get away with some of the surplus.

Long Creek Eagle: The idea that a large school building erected here in our town would not benefit only a few of our residents is to some extent absurd. If such should be built during the coming season, which we invariably believe it will, we are willing to wager anything that the opening of the school next year we will find many in attendance who have been out of school for some years, and who would never enter school again had not such an institution been erected. Again, should such a project be perfected, Long Creek would be the recipient of several families who would locate permanently here in our town that their children may receive a good education at much less expense and exposure. Let us keep agitating this school building until definite actions are taken.

STATE NEWS.

-Diphtheria reported in McMinnville.

-Bandon, Or., is to have one of the largest convents on the coast.

-The new woolen mills of Albany resumed operation 19th of last month.

-Farmers have sold but little wheat as yet on account of the low prices offered.

-The McMinnville Telephone-Register issued a mammoth advertising edition, New Year.

-Archbishop Gross arrived in Portland, 19th, from an eight month trip to Europe and the East.

-Plutarch Lewis, an honest-looking man, is under arrest in Corvallis, for stage robbery; his bonds \$1000. Dec. 26, Lewis proved to be innocent.

-While playing a game of cards with a friend, Dec. 21, Archibald Johnson was stricken with paralysis and died next day; he was in his usual good health at the time.

-An investigation, 23d ult., of the collision of the "Hoag" and "Moo-doe," Dec. 4th, shows the former in fault, and Capt. Raabe punished by loss of his license for one month.

-News from the O. P. front, Dec. 26th, states snow 16 inches deep at end of tracklaying, which work was necessarily suspended, temporarily; grading and rock work will continue. Fresh lot of supplies arrived for the men on that day.

-There are nine liquor dealers whose liquor license of \$400 each, pays the entire municipality of La Grande, which has no indebtedness and has never levied a city tax—a hasty inference would lead one to believe that nine saloons running a town is a good thing.

-From an item in the Union Scout thanking Mr. Rinehart for a fine lot of fresh oysters in the shell, one would infer that the editor gets right in and slaughters a big, fat fresh oyster by chewing it all to thunder, as he speaks of "setting our molars in the luscious bivalve."

-The West Shore for Dec. 28th, says "Oregon horses are beginning to make a reputation upon the race tracks of the United States," and gives illustrations of the following Palatino, record, 2:24; Kitty Lynch, 2:26; Wallula, 2:24; Stenwinder, 2:25; Altana, 2:24; Nautila, 2:30; Tillie Mack and Vanquish.

-Another reason why you ought to come to Oregon: Dec. 20th, Prof. W. N. Hall, of Corvallis, was for the first time in the course of eight years of married life, father of an infant. "Mr. Hall attributes his good fortune to his twelve month's residence in Oregon, and says he might have remained in Iowa forever without such luck."

-Last month, S. H. Oliver, who formerly owned \$30,000 worth of property in Benton county, was sent to the insane asylum; and Al. Wrightsman, aged 70 years, who owned, in years past, the donation claim on which Philomath college stands, died in the Corvallis poor-house. Nothing takes a man of means down so certainly as drinking and gambling.

-Representative Hermann, who complains of his low salary, receives \$5000, his mileage, and \$124 per annum for stationary and newspapers; in other words he receives a little over \$1 per hour provided he works eight hours a day every day in the year. Beecher said a man that gets \$1 for every ten hours he labors has no right to complain. It is, also, stated that Mr. H. economizes on his mileage by patronizing the Canadian Pacific, since the Democrats worked the bill through denying congressmen the right to receive dead-head railroad travel on U. S. railways. The Governor of Oregon has a show of reason for making an outcry about low wages, when talking about his salary, the Hon. Binger hasn't.
