Evidence Given in the Contest Case.

J. C. BUCKLAND—Testified that he had been a resident of Harney precinct, Harney co., for 4 or 5 years; was in Happy Valley on day of election, June 2, 1890; that Happy Valley was not in Harney precinct; that he voted in Harney Valley for the town of Harney for permanent county seat.

A. C. WORTHINGTON—Testified that he was clerk of the election at Burns, June 2; that he was acquainted with C. F. McKinney and he saw him around, and immediately at the polls during the day, and that he was in the room while the votes were counted. That Mr. McKinney challenged votes and his challenges were respected by the judges of election. He testified that C. H. McPheeters challenged C. L. Lowe and then the young man declared his age to be over 21. The young man's father was called and said that the statement made by the boy was correct that he was 21 years old. Ed Brink approached the polls and his vote was challenged by C. F. McKinney; he (Brink) did not vote, although it was possible he was of age. He also testified that C. F. McKinney was not prevented from approaching the polls, and that J. C. Garret requested that McKinney be admitted into the room while the votes were being counted as a representative of Harney, which request was granted; he further testified that no irregular or unfair proceedings were allowed at the polls and that no drunk man had been led to the polls to vote.

HARNEY COUNTY.

Area Sq. Miles, 12,000. Population 1,559.

Harney county lies directly south of Grant, and was formed of the southern two thirds of the territory. This constitutes Harney the largest county of the state. A spur of the Blue Mountains extends into the more northern part of the county and bordering upon the slopes of these an abundant supply of timber is afforded for building and fencing purposes. South of the lands of this character begin a succession of numerous valleys large and small which in the aggregate are a vast body of desirable lands for settlement, extending into ranges of grazing land almost unlimited in extent and capacity to support herds of cattle, horses and sheep, with a growth of natural pasturage unexcelled in East Oregon. Harney Valley, the largest of these, is situated about centrally in the county. It is some 60 miles long and 35 wide and is watered by the Silvies river. Magnificent meadow lands are to be found here affording abundant grass the year round. Wheat, oats, rye, barley, in fact all the productions in the most diversified farming are easily and prolifically produced. The hardier fruits and berries and vegetable grow in profusion. Agriculture has, however, advanced no farther than to supply the local demand, attention here, as so often noticed elsewhere, centering in stock horses and wool production, in which this whole region excels. Happy Diamond, Silvies and Silver Creek valleys are others lying in various directions, all awaiting settlement with fine opportunities for the immigrant. No county in the state presents so vast a quantity of unoccupied lands of greater fertility and with better climate conditions.

The following figures are from the assessment returns of 1891: Land, 368,227 \$ 718,573 Horses, 8,305 229,460 Cattle, 28,062 338,692 Sheep, 32,633 48,050 Swine, 195 798 Gross property valuation, 1,760,056

The returns for 1891 show the school population to be 792 and the amount expended for the maintenance of public schools in the county was \$7,662.63.

THE TOWNS OF THE COUNTY.

Burns is the largest town containing 400 inhabitants. It is situated in the northern part of Harney Valley on one of the proposed routes of the Oregon Pacific railroad, and on Silvies river, the largest water course in the county. Burns is now the temporary county seat, and its situation is such that will probably always be the leading town of the county because of its natural advantages. The United States Land Office of this district is located at Burns. There are two more good towns in the county, Harney, 14 miles north of Burns, and near the gold mines recently discovered on Trout Creek, and Drewsey situated on the Middle Fork of Malheur river both surrounded by an excellent farming and stock country.

The gold and silver mines recently discovered in the county will in the near future be of great benefit in the way of inducing immigration, which will develop the resources of both the towns and country.

The matter of voting booths, all bids rejected and ordered that notice be given for sealed proposals to build booths with wooden frames covered with cloth.

A proposed county road commencing at the SW corner of sec. 4, Tp. 24, R 31 East, said point being on a public highway running east, and ending at the NE corner of sec. 6, Tp. 22, R 31 East. Said proposed road rejected because of the impracticability of road and cost to the county of at least \$2,000.

A petition for a road from Saddle Butte to the Narrows. The court appointed as viewers, N. O. Ord, Ted Hayes and A. S. Swan.

In the matter of the petition of M. J. O'Connor, A. Hendricks and John T. Bailey, to change the Burns-Blitzen county road on the line between their respective claims. It was ordered that H. Elliot, Simon Lewis and R. T. Hughet be appointed viewers and T. A. McKinnon, county surveyor, view and survey said said change Jan. 11, 1892.

In the matter of the report of the viewers and surveyor on the proposed change in the county road beginning at or near the Robbins & Purrington store in the town of Drewsey and ending at a rock marked 37 miles from Burns; the change granted.
