Boundary Lines of The Voting Precincts of Harney County.

It is therefore ordered by the court that all the territory within the following boundaries shall be an election precinct.

CURRY PRECINCT.

Commencing at a point on the boundary line between Harney and Grant counties, at the NE corner of Tp. 19 S of R 27 E W M, thence West to the NW corner Tp. 19 S R 25 E, thence South to the SE corner of Tp. 21 S R 24 E, thence West to SW corner of Tp. 21 S R 24 E, thence South to the SE corner of Tp. 22 S R 23 F, thence West to NW corner of Tp. 23 S R 23 E, thence South on West boundary line of Harney county to SW corner of Tp. 27 S R 23 E, thence East on line between Townships 27 and 28 S to SE corner of Tp. 27 S R 29, thence North to the meander line of Lake Harney, thence in a Westerly, Northerly and Easterly direction along the meander line of said lake Harney to where the same intersects the Range line between Ranges 29 and 30 E, thence North to the NE corner of Tp 25 S R 29 E, thence West to the NE corner Tp 25 S R 28 E, thence North to the NE corner Tp 23 S R 27 E, thence North to place of beginning Polling place at the school house on Silver Creek.

POISON CREEK.

Commencing at the NW corner of Tp 20 S R 30 E, running thence east to the NE corner of Tp 20 S R 31 E, thence south on the Range line between Ranges 31 and 32 E to the SE corner sec 12 Tp 23 S R 31 E, thence west on north side of the county road to the SE corner sec 8 Tp 23 S R 31 E, thence north on the east line of said sec 8, to the NE corner of said section, thence west to the SE corner of sec 6 Tp 23 S R 31 E, thence north to the NE corner of SE 1/4 said sec 6, thence west on the north line of said SE 1/4 sec 6 to the west bank of Silvies river, thence in a northerly direction along the west bank of said river to where the same is intersected by the Range line between Ranges 29 and 30 E, thence north on said Range line to the place of beginning. Polling place at the Poison Creek school house.

SILVIES.

Commencing at the NW corner Tp 19 S R 28 E on the north line of Harney county, thence east along said county line to the summit of the divide between the head waters of the east prong of Calamity Creek and the waters flowing into Silvies river, thence southwesterly along said divide to the divide between the head waters of Pine creek and Cow creek and Trout creek, thence in a southeasterly direction along the divide between Pine creek and Cow creek to the NE corner Tp 21 S R 32 1/2 E, thence west along said Tp line to the NW corner Tp 21 S

R 32 E, thence north to the NE corner Tp 20 S R 31 E, thence west to the NW corner Tp 20 S R 28 E, thence north to the place of beginning. Polling place at the Walter Cross house on Trout creek.

WILD HORSE.

Commencing at the NE corner of Tp 36 S R 36 E, thence south on the east boundary line of the county to the line between Nevada and Oregon, thence west on said state line to the line between Lake and Harney counties, thence north on said line to where the same intersects in Tp 37 S R 29 E, thence easterly and northeasterly along summit of said mountains to the SW corner of Tp 35 1/2, thence east along the Tp line to the county line at the NE corner of Tp 36 S R 36 E, the place of beginning. Polling place at the house of Peter Andreas in Wild Horse Valley.

ALVORD.

Commencing at a point on the summit of the mountains on the east boundary line of Harney county, thence south on said boundary line to the SE corner Tp 35, thence west to the summit of Steens mountains, thence in a northeasterly direction to the place of beginning. Polling place at Alvord Ranch house.

HARNEY.

Beginning at the NW corner of Tp 21 S R 32 E, thence east on the north line of said Tp to the NE corner of Tp 21 S R 32 1/2 E, thence south 3 miles, thence east 3 miles, thence in a southeasterly direction to the NW corner of Tp 22 S R 34 E, thence east to the NE corner sec 3, thence south to the SE corner sec 33 Tp 22 S R 34 E thence east to the SE corner of Tp 23 S R 34 F, thence south to the SE corner Tp 23, S R 34 thence west to the Range line between Ranges 31 and 32 E, thence north to the place of beginning. Polling place at school house in town of Harney.

BURNS.

Commencing at the SE corner of Tp 19 S R 27 E W M, thence East on said section line to the SE corner of Tp. 19 S R 29 E, thence South on the Range line between Ranges 29 and 30 E to where the same intersects the West bank of Silvies river, thence in a Southerly direction down and along the West bank of Silvies river to the county bridge at Geo. Stancliff's place in Section 6 Tp. 23 S R 31 E W M, thence East on the North line of the SE 1/4 of Section 6 Tp. 23 S R 31 E to the NE corner of said SE 1/4 Sec 6, thence South to the SE corner of said Section 6, thence East to the NE corner sec 8 Tp 23 S R 31 E, thence south on the east line of sec 8 to the county road on the south line of said sec 8, thence east on said county road to the NE corner of sec 13 Tp 23 S R 31, thence south on the east line of said sec 13 to the NE corner sec 25 Tp 23 S R 31, thence west two miles to the NW corner sec 26 Tp 23 S R 31 E, thence south one mile, thence west two

miles, thence south one mile, thence west one mile to the SE corner sec 31 Tp 23 S R 31, thence south on the sec line between sections 5 and 6, 7 and 8, 18 and 17, 19 and 20, 30 and 29, 31 and 32 to the SE corner sec 31 all in Tp 24 S R 31 E, thence west on the Tp line between Tp 24 and 25 S to the SW corner of Tp 24 S R 29 E, thence north on the range line between Ranges 28 and 29 to the NE corner Tp 23 S R 28 E, thence to the NW corner said Tp and Range, thence north to the place of beginning. Polling place at the district school house in the town of Burns.

PINE CREEK.

Commencing at a point on the summit of the mountain on the divide between the head waters of the west prong of Pine creek and the east prong of Cow creek and the waters flowing into Silves river thence in a northeasterly direction to the county line between Harney and Grant counties, thence east along said county line to the Range line between Ranges 34 and 35 E, thence south on said line to the SE corner of Tp 19 S R 34, thence west on the south line of said Tp three miles, thence due south on the section line between sec 3 and 4 to the north line of Tp 22 S R 34 E, thence west three miles, thence north three miles, thence west three miles, thence north to the NE corner Tp 21 S R 32 1/2 E, thence in a north westerly direction on the divide between Pine creek and Rock creek and Cow creek to the place of beginning. Polling place at the Pine creek school house in said precinct.

HAPPY VALLEY.

Commencing on the east line of Harney county at the NE corner of Tp 28 S R 36 E, thence south to the summit of mountains, thence in a southwesterly direction along said summit to the ridge dividing Happy Valley and Diamond Valley (that is to say midway between the most westerly waters flowing into Happy Valley and the most easterly waters flowing into Diamond Valley, thence in a northwesterly direction along said ridge to the SE corner of sec 33 Tp 28 S R 32 E, thence north to the NW corner sec 3 said Tp and Range, thence due east on the Tp line to the NE corner of Tp 28 S R 36 E to the place of beginning. Polling place at the district school house in Happy Valley said precinct.

SADDLE BUTTE.

Commencing at the NE corner of Tp 24 S R 33 E, thence due south on the east line of said Tp to the SE corner of Tp 27 S R 33 E, thence west to the SW corner said Tp and Range, thence north on the west boundary line said Tp and Range to the SE corner of Tp 25 S R 32 1/2 E, thence west to the SW corner said Tp and Range, thence north on west line of said Tp to the SW corner sec 18 said Tp and Range, thence west on the line between sections 13 and 24, 14 and 23 Tp 25 S R 32 to the SE corner sec 15 Tp 25 S R

32 E, thence north on the east line of said sec 15 to the NE corner sec 3 Tp 24 S R 32 E, thence east to the NW corner of Tp 24 S R 33 E to the place of beginning. Polling place at the district school house in said precinct.

DIAMOND.

Commencing at the SE corner of sec 33 Tp 28 S R 32 E, thence in a southeasterly direction along the divide or ridge between Diamond Valley and Happy Valley to the summit of the mountains, thence along the summit to the divide between the extreme southern head waters of Dunder and Blitzen river and the head waters of Catlow Valley, thence in a northwesterly direction along said divide to the NE corner of Tp 33 S R 31 E, thence west to the SW corner of Tp 32 S R 23 E, thence north on the west line of the county to the north line of Tp 29, thence due east on the Tp line to the SE corner of sec 33 Tp 28 S R 32 E the place of beginning. Polling place at the district school house in Diamond Valley said precinct.

LAKE.

Commencing at the NE corner sec 23 Tp 25 S R 32 E, thence east on the Tp line, thence south on the east line of said Tp to the SE corner thereof, thence East to the SE corner of Tp 25 S R 32 1/2 E, thence south on the Tp line to the SE corner of Tp 27 S R 32 E, thence west to the NW corner sec 3 Tp 28 S R 32 E, thence on the sec line between 3 and 4 said Tp and Range, to the SE corner sec 33 said Tp and Range, thence west to the west line of Harney county, thence north to the NW corner of Tp 28 S R 23 E, thence east to the NE corner Tp 28 S R 29 E, thence north to the margin of lake Harney, thence following the margin of said lake in a northwesterly direction to the Range line between Ranges 29 and 30, thence north on said line to the NE corner of Tp 25 S R 29 E, thence on the Tp line to the NE corner sec 6 Tp 25 R 31 E, thence south to the SE corner sec 18 said Tp and R, thence east on the sec line between sections 17 and 20, 16 and 21, etc., to the NW corner sec 23 Tp 25 S R 32 E, the place of beginning. Polling place at residence of A. Hembree.
