A Hallelujah Wedding.

About 400 people turned out last night at Chatsworth Hall to see the "Hallelujah wedding" of Jesse Morris Spinks and Miss Alice Rebecca Smith under the auspices of the Salvation Army, of which both are members. One peculiar feature was the admission fee of 15 cents, the proceeds of which will go into the treasury of the army.

Promptly at 7:30 o'clock the army paraded down the steps of the hall and out into the streets headed by the kettle and brass drums. A march followed around the streets for half an hour. The wedding pageant then returned to the hall and every available seat on the stage was taken by the followers of the cause.

When they were all seated the bride and groom appeared and were greeted with tremendous applause. They took seats in the center and a dozen girls in white appeared up on the stage and sat down on the right, while the band faced them from the other side. At the side of the groom was the best man, Captain L. Irving, and Miss Jennie Jacobs, the bridesmaid, took a seat next to the bride.

"There is a fountain filled with blood" was then sung. This was followed by, "O Lord, my soul prepare," and then Captain Irving sang a solo entitled, "O My Golden Crown." The echoes of this song had hardly died away when Captain Robinson sang "He's Just the Same To-Day." Captain Jordan followed with a song entitled "Salvation." Captain Fannie Baunster and Private Bessie Hunter, who had come all the way from Hannibal to witness the nuptials, came forward and made speeches about how good the Lord is to members of the Salvation Army.

Captain John Bovill, who had been imported from Kansas City to pronounce the couple man and wife, came forward and read the Salvation ceremony. The "I do" and "I will" were answered in regular form by the couple, who had taken a position in front of the Captain. The "in the name of God I pronounce you man and wife" was then said and everybody clapped their hands.

Captain Boville sang "Take back the heart I gave you" and loud calls were made for Spinks. He reluctantly came forward with his hands to his face, as if in prayer to the Lord for strength to face the crowd, when a man in the back end of the house halloed: "Cheer up, Jesse."

Jesse cheered up, and said he thought he and his wife "were very well put together."

The audience arose as one man and gave a prolonged cheer, the applause lasting for about five minutes. A call was then made for mourners, but, none appearing, the

ceremony was pronounced ended and an adjournment was taken to a rear room, where a supper was prepared.

The festivities went on until 11 o'clock, when the members of the army and guests departed for their homes.—Republic

Makes Fast Time On A Bike.

Miss Lillie Williams, the champion female bicyclist of the world, arrived in New York from Jamaica. She said to a World reporter: "I was born in Memphis, Tenn., but first attempted to ride a wheel in Omaha. It was in 1889, and I was at that time stenographic reporter for the courts in Omaha. My health was exceedingly poor and I began the wheel as a matter of exercise. I took to it very readily, and about that time six well known female riders came to Omaha, and, hearing of my riding, challenged me to a race. The challenge put me on my mettle, and, although I had had but one month and eighteen day's practice, I accepted, and defeated them, too. I have won the 18 hour championship five times, so I guess it belongs to me. My record for that time is 262 miles. In 1890 I won the 24 hour championship at St. Joseph, Mo., making 368 miles, thus breaking the record by 12 or 15 miles. I have also won the 48-hour championship.

"In February, 1890, I rode against three French women in Paris. The race was 100 miles, and I made it in 6 hours 20 minutes, winning by a mile on a 12 lap asphalt track.

"I have beaten a number of leading male riders, but only in handicap races. I would not attempt to run an even race with a man, for a woman has not a man's power of endurance.

"My best time has been one mile in 2:58; two miles in 6:22, and five miles in 15:30. The most exciting race I have ever run was at Sheffield, England, when I made ten miles in 31 minutes."

Miss Williams will contest the championship with various noted riders at the Columbian Exposition.

Echo of the wann Horror.

ALTON, Ill., Feb. 2.—Shortly after the awful disaster at Wann by which so many lives were lost and fully a hundred people were injured stories of a horrible nature began to be told of the cruelty and inhumanity of one, only one, man at Wann, who not only refused shelter to the injured, but drove them from his door, even, it is said, kicking one of them out who had entered his saloon and boarding-house.

Not much credence was at first given to these tales, as they were considered too frightful for belief, but they have been so constantly repeated and certified to by reliable parties that belief has become almost compulsory. This man's son was one of the injured and has since been hanging between life and death by a thread.
