NEWS IN GENERAL FROM OUR EXCHANGES.

I believe there is no longer any controversy as to relative shooting capacities of large and small guns. I can recall, however, when the war of words between champions of ten and twelve gauges waxed furious. The superiority of a large weapon was demonstrated to my own satisfaction at that time by the use of an extreme example. While on a hunting expedition I came across a pot-hunter who had a gun about which he told astonishing tales. The gun is an eight-bore muzzle-loader weighing eighteen pounds! The tales related chiefly to the mowing of swaths in the ranks of water-fowl at rest, for the man was the most shameless of pot-hunters. Sixteen geese at once discharge, forty odd teal or another, were, I recall, among the dischargeful records notched, so to speak, on the stock of this old gun. This did not interest me. But when I was told that it would "kill sure" at one hundred and twenty yards my curiosity was aroused, and I determined to put the gun to a legitimate test, the owner offering to loan it for that purpose. So I had it carried one morning to a point over which ducks were flying very high; so high, indeed, that they paid no attention to me, though I stood in full view. Finding first that my own gun failed to reach the game, I loaded the cannon with "about a handful of powder, and as much shot as you please," according to the owner's not very explicit instructions; and the next pintail that attempted to pass over was brought down from just below the cloud line like a meteor. I repeated the experiment until I was fully

Bob Hatfield Killed.
PARKERSBURG, W. Va., March 22.—The Hatfield-McCoy feud, which has slumbered quietly for several years, has again broken out in Logan County, and affairs are beginning to assume a serious aspect. Bob Hatfield, son of "Devil Anse," and Mose Christian, both of the Hatfield faction, were killed by the ex leader of the McCoy's, Frank Phillips. Several men from that section who arrived here to day as witnesses in the United States Court, give the following account of the affair:
Last Friday Frank Phillips, who was one of the most notorious leaders of the McCoy faction during the last feud, in which many lives on both sides were lost, came down from his headquarters in the mountains of Kentucky and crossed the boundary at St. Peter's Creek, where he learned that Bob Hatfield, son of Anse Hatfield, was somewhere near. Phillips had always claimed that Bob Hatfield was the man who shot and came near killing him in the last feud, and he determined to kill him. Mose Christian, a friend of Bob Hatfield, heard the firing and ran to his assistance and was also shot by Phillips and mortally wounded. Phillips had seven men with him at the time and after shooting the men they escaped into Kentucky. The Hatfields are said to be collecting their forces to avenge the murder of Bob Hatfield and Christian.—The Republic

THRICE CONVICTED.

SEATTLE, March 23.—A Snodgrass special says that the jury in the Robinson murder case today brought in a verdict of murder in the second degree, making the third conviction for the brutal murder of George Shoultes and Fred Schmidt, farmers, at Dubuque. Snodgrass county, on December 22, 1892, by two boys named George Robinson and John Livingstone, who were incited to the crime by John Robinson and John White. This was James Robinson's second trial, he having been acquitted last September of the murder of Shoultes. He was immediately re-arrested for the murder of Schmidt. John White was convicted of murder in the first degree after the trial in June, 1893. He was sentenced to hang in September following, but an appeal was taken and he is now in jail pending the decision of the supreme court. Last October the two boys, George Robinson and John Livingstone, were convicted of manslaughter and sentenced to 18 years in the penitentiary. Bill Robinson, the last of the murder-

Bank Cashier Murdered.

SAN FRANCISCO, March 24.—A man entered the branch office of the San Francisco Savings Union, at the corner of Market and Fell streets, this morning, and presented a piece of paper to Assistant Cashier A. Herriek. After examining the paper Herriek returned it. An altercation between the man and cashier ensued, during which the former drew a pistol and fired seven shots in rapid succession, killing the cashier almost instantly. The murderer then fled but was soon captured by the police. He gave the name of Fred Borneman and said he was recently from Denver. The paper presented to Cashier Herriek by his murderer was a note written in red ink stating that the bearer should be given money or he would blow up the place with dynamite. On the top of the man was drawn a skull and cross bones.—Bedrock Democrat.

TO RETURN THE NEGROES TO AFRICA.

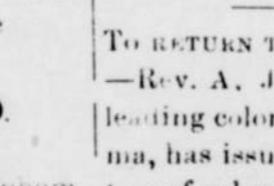
—Rev. A. J. Warren, one of the leading colored ministers of Alabama, has issued a call for a convention of colored people to convene in Birmingham, Ala., March 21. The object of this convention is to consider the question of general immigration to Africa, and the call is the result of the National Colored Convention held in Cincinnati last November. The leaders of this move have practically the same views as Bishop Turner, who says that Africa is the real home of the negro, and the sooner he gets there the better off he will be. It is thought that at this convention definite steps will be taken by the Alabama contingent.

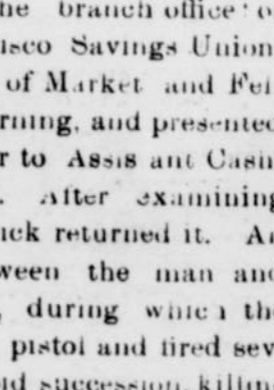

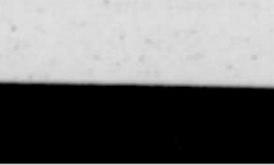
