The following is the most important clauses in the platform after the endorsement of free coinage.

We denounce the act of the last legi-lature whereby was repealed what is known as "The Mortgage | Tax Law," and we demand its reenactment at the next session.

We demand that all property shall be assessed at its true cash value, and that there shall be deductions only for indebtedness which has a corresponding taxable credit.

We are in favor of liberal appropriations for the improvement of our rivers and harbors, and the adoption of such measures as will tend most speedily to the opening of the Columbia river.

We are opposed to Chinese and all pauper immigration.

We are in favor of the abolishment of railroad and all other unnecessary commissions.

We favor fixed salaries for all public officers and the abolishment of the fee system, and are opposed to an officer receiving more than his constitutional salary.
