

THE Tribune of Salt Lake City in a recent issue give an account of an artesian flow of water at a depth of 1073 feet This well is known as the Rio Grande Western's Artesian Well. The Tribune says "the sinking of this well the method of boring and the stratification to a depth never before penetrated in Salt Lake valley, should prove of equal interest to agriculturists and geologists and this interest should be shared by all who are interested in the question of drawing on subterranean water for irrigation."

A flow of 120 gallons per minute with a force of 4 feet above the surface, was struck at the depth already mentioned. Messrs. Westphal & Candee struck the flow, the same Westphal who was here and assisted Kellogg in our effort to get an artesian well.

The well was commenced with a six inch pipe and at the depth of 500 feet the six inch pipe was abandoned and a four inch pipe substituted. When this change was made Westphal & Candee took charge of the work, and they introduced a method of boring ahead of the pipe instead of driving it. This apparatus is a revolving column of two inch pipe running inside of the well, and adjusted so as to be raised or lowered at pleasure. at the lower end a cutting tool is attached made on the principal of an auger and the upper is connected by hose to a powerful pump, which forces water to the bottom and washes out the borings. It is further stated the flow is constantly increasing since boring has been discontinued. Accurate measurements taken three days apart show an actual increase of eight gallons per minute and an increase in the pressure.

There has never been a doubt in our mind as to the result of this county's effort to obtain a big flow of artesian water had the effort been carried to completion what we mean by completion is remove the tools and obstructions from the hole we have already in the ground and we have a large flow of water. The effort nearly carried to success and abandoned as it was, with the evidence we had of success, was more like the action of children than of men and citizens of a county, who speak as if they were anxious for the development and settlement of our county.

If this mode of irrigation is essential to our prosperity why not bring it before the people and let them say by their votes whether or not we will carry out the plan of taxing the citizens for this purpose or not.

If we really desire this county settled and developed our actions certainly speak to the contrary.
