CANYON CITY, May 11, '96.

Died in this city Monday morning May 4, at 3 o'clock, of acute congestion of the brain and spinal cord, Mrs. Annie Lahey, daughter of Mrs. T. M. Britten, aged 24 years, 3 months and 12 days.
