ELECTRIC LIGHT AND WATER

People of Burns Vote on the Question Monday—The Offer Already Submitted.

Monday the voters of Burns will decide whether or not we are to have electric lights and a water works system. The city charter invests the power in the mayor and common council to decide in the matter and also gives them the absolute power of issuing bonds for the purpose, but that body has waived their right and will leave the choice, to have or not to have, with the people. Some lively discussions have been entered into during the past week by supporters of the proposition with a number of others who have opened up a warm campaign against it, and the vote on the question is liable to be very close. The opposition base their fight on the claim of higher taxes, depreciation in value of property, a detriment to future growth and a gradual decline to the boneyard, while those supporting the question claim that a better fire protection would decrease the rate of insurance and enhance the value of all property to the extent, at least, to counter-balance the increase of taxation, and above all, that with a system the council would install, the permanence of the place would be more firmly established. In last week's issue we made mention of a proposition submitted to the city council by E. N. Ayer, of Portland, representing the Pacific Electric Co. Below we give his proposition, but we understand if the people decide to have an electric light and water works system, the matter will be open for bids to all persons who wish to submit them, and from these, if any are satisfactory, the council will select the lowest and best bid. The proposition already submitted and mentioned above is as follows: To the Hon. Mayor and Common Council, Burns, Oregon. Gentlemen: We propose to furnish you with the following apparatus, supplies and labor: A complete electric light plant of 600 light capacity, consisting of one 2000 volt alternating dynamo complete with instruments and fittings; one 50 horse automatic high speed engine; one 50 horse power tubular boiler, both engine and boiler to be complete with necessary piping, fittings, etc., and all poles and lines to the principal points of the city where present customers may be found; 400 light capacity in transformers, necessary wires to drop from transformers to buildings, and all insulators, bushings, belts, labor, etc., necessary to complete the plant. This plant to be delivered at Burns and set up on a location which will be supplied by us, and put in first class operating condition; all material, machinery, etc., used to be new and first class in every respect; to be the latest design of the various manufacturers. We, also, will furnish you a water works system, consisting of a 20,000 gallon capacity reservoir, erected at a sufficient height for the necessary pressure, the same to be built in the neighborhood of your present school building, and on such real estate as you may furnish. Said reservoir to be constructed in a first class workman like manner, and of suitable timber on a good substantial foundation. Also on this real estate we will put down a suitable dug well to furnish water for town purposes, and in said well

locate a 50,000 gallon capacity pump, with all piping and fittings, said pump to be gear connected to a suitable electric motor to drive it. Starting from the reservoir we will furnish and lay a six inch main along A street to Second, and a six inch main along Second street from C to Madison, and a four inch main from Second along Madison to Front street. On this pipe line we will furnish and install eight hydrants at such places as the council may direct. All work will be done in a thorough workman like manner, and all material will be new and the best of their respective classes. The system to be delivered to you complete and in a first class operative condition. Price, \$12,850. Terms as may be agreed on and subject to the following conditions: We will on the completion, give to you a clear title to the water works system, furnish you electric current to pump water for fire purposes without cost to you, for a period of ten years. The electric light plant, franchise good will and reverses of same to be our property for a period of ten years; and at the expiration of this time the plant to pass into the possession of the city without further payment, excepting, all improvements and additions that may have been added during the ten years time, and which were not a part of the original installation, the same to be paid for at actual cost. Huntington Herald. John H. Mitchell, United States senator for Oregon, passed through Huntington last Sunday on his way to New York.
