cient funds are available for completing it. Upon the completion of each irrigation project the lands to be irrigated shall be subject to homestead entry, and entrymen, on making final proof, shall pay \$5 per acre, to be converted into the reclamation fund.
Entries shall not embrace over 80 acres. When the payments contracted for are made upon the major portion of the irrigable system, the management and operation, but not the title, to the works, except reservoirs, shall pass to the owners of the land thereby irrigated, to be maintained at their expense. All reservoirs and works necessary to their protection and operation shall be maintained by the Government as public works. The right to the use of the water is perpetual.


