Supreme Court Decision.

The following is among the decisions handed down by the Supreme Court this week :

Henrich Volp, appellant, vs. Board of Medical Examiners respondent, from Multnomah County, M. C. George, Judge, affirmed;

On June 13, 1902 Volp applied to the State Board of Medical Examiners for an examination as to his qualification to receive a license to practice medicine and surgery. His examination proving unsatisfactory, the board issued to him what was intended to be a temporary license only or a permit to practice for six months in the following form: "This certifies that Henrich Volp, having passed a satisfactory examination in medicine and surgery before the Board of Medical Examiners, is hereby authorized under the provisions of the act to regulate the practice of medicine in the State of Oregon, ary, 1889, to pursue the practice of medicine in this state under the conditions of aforesaid act, till December 13, 1891." On March 30, 1895, Volp presented this certificate, with the words and figures 'till December 13, 1891" erased, to the secretary of the board, by whom it was recorded. On July 2, 1895, Volp filed the certificate in the office of the County Clerk of Multnomah County, and on July 7, 1897, secured a certified copy thereof, which he filed in the clerk's office in Harney County. On May 23, 1900, W. L. Marsden made complaint to the board, charging Volp Your patronage Socieited. with having fraudulently changed the certificate, and the board gave Volp notice through the mail that in this city Saturday evening, April on January 4. 1901, the charge would be investigated. Volp admitted making the erasure, and said he make it because the board had no right to issue a temporary license. The Supreme Court holds that

> the board had no authority to issue a temporary license, and that the license it did issue was void. "The simple solution is that the board exceeded its authority in issuing the form of lisense adopted. It had no intention of issuing a regular license. The applicant had not come up to the prescribed standard under his examination, and, acting upon a generous impulse toward him, so that he might yet have an opportunity of qualifying himself, and in the meanwhile engage in his adopted profession, the board gave him the permit to practice for six months. To construe such an act into absolute regularity and the permit of six months' duration into a license, would be to contort an irregular and void proceeding into one of due regularity and perfect legal efficacy. His erasure cannot by any rule of ethics or practice, either in law or morals, operate to admit him as a regular practitioner of medicine and surgery; so that he has never been by any act of the board licensed generally to practice his profession, but by his own willful act he has procured the making up of a record which is false, and without the power of either the hoard or its clerks to make.


