The Project consists of constructing a **Chlorination System for the wastewater irrigation, modifying the storage lagoon out let, a new water service and pressure booster pump, and providing (3) diesel generator sets for the existing lift stations. Alternate additive items include replacement of wastewater submersible pumps for two of the lift stations, improvement to the access of City Hall, remodeling the restrooms to be ADA compliant, and repairing leaks on a sewer manhole.**
