The spring turkey hunt season began April 15 in Oregon, with wildlife officials saying numbers are

Last year's spring harvest of 4,229 turkeys was up nine percent from the previous year and the highest since 2010. This year's season could be even better, according to Oregon Department of Fish and Wildlife.

"With the mild winter, more turkeys survived the season, particularly in areas of Eastern Oregon where winter weather can be a limiting factor," said David Budeau, ODFW upland

Mikal Moore, Pacific Northwest regional biologist with the National Wild Turkey Federation (NWTF), agreed.

"Expanding turkey populations coupled with favorable over-wintering conditions should make for a very exciting wild turkey season this spring," she said.

Hunters say all it takes for a good spring hunt is camo, a call, and a shotgun. A hen or jake decoy can also improve the odds.

The hunt runs to May 31 statewide, and hunters can buy up to three turkey tags in some areas. There is no deadline to buy a tag, which can be purchased just be-




