JOHN DAY - The Grant County Health Fair, coming up on Friday, June 19, offers a packed lineup of health and wellness professionals, in addition to the tests that are the main event.

The fair will be from 6 a.m. to noon in the Grant Union Junior-Senior High School gym in John Day.

People can register at the fair, or they can sign up and pay in advance at Blue Mountain Hospital from 8 a.m. to 5 p.m. on Friday, June 12, or Monday through Thursday, June 15-18.

This year the regular blood test costs \$35, and the TSH thyroid test can be added for \$15. The PSA test for men is

The Grant County Health Department will offer A1c testing for diabetes for \$10, tetanus shots for \$20, and iron and height/weight checks.

An array of booths will offer information on topics ranging from nutrition to skin care to emergency services.

It started as a health and safety event in 1994, with the Malheur National Forest partnering with Grant County Health Department, Blue Mountain Hospital and local law enforcement. Fay E. Page, 91, of Mt. Vernon died Saturday May 23, 2015, at Blue Mountain Care Center in Prairie City. No public services will be held.

Fay was born to Columbus Phillips and Lillie Stratton in Bear Valley, OR on October 28, 1923. Her early years were spent on Rosebud Creek in Izee where she and her sister Billy would always ride horse-back to school. In 1932 the family moved to Union, OR., another move followed to North Powder, OR., and then back to Izee in 1938; Fay then graduated from Grant Union High School in 1941. It was said she was the fastest runner in the school during her time there.

After graduation she moved to Prineville, OR and stayed with the Brease family while working in the Crook County courthouse. While there she became the Queen of the Crook County Roundup, and served on the court with a fellow person from Grant County, Mickey Reynolds.

After returning to Grant County, Fay worked at the Malheur Forest Office, and in 1952, she married Charlie Page and had two sons, Ford and Richard. They eventually divorced and Fay moved to Butteville, OR and worked in Portland, OR for the Forest Service experiment station. Later she was severely injured in a horse accident and was forced to take an early retirement. After retiring she moved to a small ranch in Heppner, OR and in 1989 moved back to Grant County to her son's ranch near Moon Creek.

Although Fay had lived away from Izee for many years, she always talked about riding through "those

She enjoyed the simple things in life; things like the smell of fresh air after a rainstorm, and the change of seasons. She loved horses, cattle, and dogs; all of them must have behaving nature of course. She also enjoyed her yard, flowers, fishing, hunting; it wasn't uncommon to be hit by a flying fish after a big jerk of the fishing pole. The sight of a large buck would excite her, and everyone knew to take cover because the "lead was going to fly." She truly enjoyed attending her grandchildren's sporting events.

Fay was preceded in death by her parents, sister Elizabeth "Billy" Phillips Luce, a son Ford, brother-inlaw Lloyd Luce, and nephew Phillip Luce.

She is survived by son Richard Page of John Day, OR., 4 grandchildren William of La Grande, OR., Tyler of Boise, ID., Nolin (Alexandra) of Prairie City, OR., Katelyn of Missoula, MT., niece Fay Ann (Joe) Kehr of Redland, OR., and special friends Russ and Jeannie Haehle of Belleview, WA.
