# Counsel reviews road ordinance

CANYON CITY - The enforcement potential for Grant County's road or public access ordinance appeared murky this week, with the release of an analysis by the county counsel.

Ronald S. Yockim, the county's lawyer, said in an email to the County Court that a county challenge of a Forest Service road closure would likely end up in federal court.

Yockim's comments came in response to questions from County Commissioner Chris Labhart.

Labhart said he sought an opinion from counsel after hearing so much discussion about the ordinance and whether it is enforceable.

"I wanted to get to the bottom of this," he said. "It has no enforcement clause, and I was concerned about that."

The county adopted a public access ordinance in May 2013 that requires that roads, trails and other traditional byways on the public lands remain open unless authorized for closure by the sheriff and County Court.

Labhart asked four questions, starting with a query about the validity of the ordinance since it doesn't address enforcement.

Yockim noted conflicting statutes regarding whether enforcement must be addressed in an ordinance, or is implied by the definition of a violation. He concluded "it is a question that may not be resolved absent a court test or modification by the county to clarify the ordinance."

On the issue of enforcement powers against public agencies, Yockim called that "a crux issue."

He suggested the enforcement would be against an individual, such as the public official making the decision. As a general rule, he noted, public officials have immunity when acting in their official capacity and cannot be sued individually.

His analysis also suggested the Constitution's Property Clause could limit the authority to apply the ordinance to all roads under public ownership. He called the RS 2477 roads "a limited subset of roads that may fall within the purview of the ordinance."

Yockim, in his analysis, repeatedly notes the difficulty of addressing all scenarios without specific facts.

Yockim wrote that the ordinance is enforceable "in the same manner as other ordinances," but "if any action was brought against the agency or its employees one should expect the matter would eventually be transferred to federal court.'


