# **Advisory committee** member sought

The Northeast Oregon Forests Resource Advisory Committee is seeking nominees to serve on a 15-member Resource Advisory Committee.

The committee's duties include recommending projects and funding to improve forest health, watersheds, roads and facilities on or adjacent to the Malheur, Umatilla and Wallowa-Whitman national forests.

Past projects include: noxious weed control, trail construction, thinning and improvement of fish passage to restore native species.

Advisory committee members will be officially appointed by the Secretary of Agriculture for a term of two years. They will not receive compensation, but a per diem allocation will be made to compensate for expenses associated with attending meetings.

Members must be able to attend one or two full-day meetings each year.

To the extent possible, members should reside within Grant, Baker, Crook, Harney, Malheur, Morrow, Union, Wallowa or Wheeler counties.
