Sep. 30, 1915 Grant County Journal Booster Here

Mr. J.W. Brewer, of the Farm Lands Department of the Portland Chamber of Commerce and Oregon Development League, passed through Prairie last Tuesday on his way to the county fair at John Day, where he expected to spend two or three days looking at what is raised in this section and gathering information in regard to the possibilities of the John Day Valley.

The organization back of Mr. Brewer is one of the strongest of its kind in the United States, both in point of membership and finances and is taking a great interest in the development of the whole state. Recognizing the fact that Portland draws its wealth from all of Oregon, and very largely from Eastern Oregon, they are taking an interest in settling this country

Mr. Brewer is very favorably impressed with the John Day, having been here before, and hopes to see a lot of good accomplished here



Alien registration in Grant County seems to be going along well as may be expected but some doubt seems to exist in the minds of aliens as to what to do before applying for registration says postmaster Ed Hoare.

The first thing to do, and this is very important, is to go to the local post office and get the first form, to be filled out at home. Certain information called for on this form can not be furnished except from records and these records must be consulted before any registration can take place.


