## Milo Pope

July 18, 1936 — Feb. 24, 2016

BAKER CITY — Milo Pope, 79, died Feb. 24 at his Baker City home. Per his request, no funeral services will be held. A private family memorial will be observed this month.



Pope was born July 18, 1936, the fourth of five children to Milo and Grace Pope in Hoquiam, Washington.

He was raised in Sutherlin and John Day. He graduated from Grant Union High School in 1955. It was in high school that he met his future bride Gayl Kilpatrick.

On Nov. 20, 1958, they married in John Day and together had three children, Marcia, Kevin and Milo.

In 1961, he began his law career in Idaho. He practiced in Twin Falls, Idaho, Milton-Freewater and John Day. In 1988, he was elected circuit court judge of Grant and Baker counties and subsequently moved to Baker City.

He enjoyed his time on the bench. He brought his empathetic and no-nonsense sentiments, which have left a lasting impression on friends and colleagues alike.

After retiring, he continued to practice law, a profession that he enjoyed greatly, and acted as a mentor to many. He had great respect for the law, gave of his talents in many great ways and was dedicated to providing the best possible counsel to all those he served.

He was an avid reader and a lover of language, often correcting his children's and grandchildren's grammar, or asking how to spell novel words. He was always curious about the world. He loved people and his community, serving on city council and writing many letters to the editor. He enjoyed woodworking, a skill he admired in his father, and often spent time with friends in his shop.

Survivors include his siblings, Beverly Nordquist, Bruce Pope and Nila Palmer; children, Marcia (Bill) Winter, Kevin Pope and Milo Dion Pope; and grandchildren Genevieve Ehart, Rebecca Adair, Melissa Winter, Thomas Ehart, Bill Winter and Mike Ehart.

They spent the early years of their marriage in Milwaukee, Wisconsin. Upon moving back to the Benoit area, they purchased a small dairy farm which they ran until he died in 1967.

# Warm February follows cold January

JOHN DAY — According to preliminary data received by the National Weather Service, temperatures at John Day averaged warmer than normal during the month of February.

The average temperature was 39.3 degrees, which was 3.2 degrees above normal. High temperatures averaged 52.7 de-

grees, which was 5.3 degrees above normal. The highest was 66 degrees on Feb. 10. Low temperatures averaged 25.9 degrees, which was 1.1 degrees above normal. The lowest was 1 degree, on Feb. 2.

There were 22 days with the low temperature below 32 degrees.

Precipitation totaled 0.52

inches during February, which was 0.23 inches below normal. Measurable precipitation — at least .01 inch — was received on five days with the heaviest, 0.34 inches reported on Feb.

The highest wind gust was 38 mph which occurred on Feb. 17.

The outlook for March

from NOAA's Climate Prediction Center calls for above-normal temperatures and near-normal precipitation. Normal highs for John Day rise from 51 degrees at the start of March to 57 degrees at the end of March. Normal lows rise from 27 degrees to 31 degrees. The 30-year normal precipitation is 1.27 inches.

# Snowpack much closer to normal than last month

# John Day **Basin still** highest in state

Snowpack in the John Day Basin is the highest in the state, but the amount dropped significantly since last month.

As of March 4, basin snowpack was 108 percent of normal, compared to 141 percent last month. Snowpack at the Starr Ridge SNOTEL site, elevation 5,250 feet, was 12 inches March 1 — 87 percent of the median snow water equivalent.

February precipitation in the basin was 70 percent of average, compared to 106 percent from Oct. 1 to March 1. Summer streamflow forecasts in the basin range from 91 percent to 114 percent of average. These forecasts also decreased significantly from last month.

Statewide, snowpack is at 92 percent of normal. The Mt. Hood and Willamette Basins, at 77 percent and 76 percent, are the lowest in the state. Most basins in the state are within 90 percent to 109 percent of normal.

As of March 7, Canyon Creek at Thissels Ranch was at 5.31 feet, with flood stage at 6 feet. Canyon Creek near Canyon City was at 5.05 feet, with flood stage at 6 feet. John Day River near John Day was at 4.88 feet, with flood stage at 8 feet.




