Kodesh pleaded guilty to third-degree assault, a Class C felony, and menacing, a Class A misdemeanor, July 27 in Grant County Circuit Court.

John Day City Council members opted not to require permits for people renting rooms in their homes during the solar eclipse.


said requiring special permits would likely require home inspections. He said the council voted unanimously against requiring the special permits for
