## **Public Notice and Notice of Public Hearing**

The City of Monument is eligible to apply for a 2016 Community Development Block Grant from the Oregon Business Development Department. Community Development Block Grant funds come from the U.S. Department of Housing and Urban Development. The grants can be used for public facilities and housing improvements, primarily for persons with low and moderate incomes.

Approximately \$12 million will be awarded to Oregon non-metropolitan cities and counties in 2016. The maximum grant that a city or county can receive is \$2,500,000. The City of Monument is preparing an application for a 2016 Community Development Block Grant from the Oregon Business Development Department for a Water Master Plan. It is estimated that the proposed project will benefit at least 127 persons, of whom 56.9 % will be low or moderate

A public hearing will be held by the City of Monument City Council at 6:00 P.M. on Wednesday September 14, 2016 at the Monument Senior Center. The purpose of this hearing is for the City Council to obtain citizen views and to respond to questions and comments about: community development and housing needs, especially the needs of low- and moderate-income persons, as well as other needs in the community that might be assisted with a Community Development Block Grant project; and the proposed project.


