Rural veteran transportation funding awarded

Free transportation to medical appointments available for veterans

The Oregon Department of Veterans' Affairs has received another federal VA grant to invest a half-million dollars into the transportation needs of veterans living in highly rural Oregon counties.

Distance and transportation to and from appointments are routinely cited by rural veterans as the main obstacles to obtaining health care. Oregon has 10 counties that are considered "highly rural" by the U.S. Census Bureau: Grant, Baker, Gilliam, Lake, Harney, Malheur, Morrow, Sherman, Wallowa and Wheeler.

More than one-fifth of Oregon's veteran population lives in one of these highly rural areas.

"It's not enough to just provide quality health care for veterans. We must also ensure that all veterans have access to it - no matter where they choose to live," ODVA Director Cameron Smith said. "We are proud to collaborate with our local partners to continue to reduce barriers for rural veterans to access care at the VA and in the community."

For the past three years, Oregon has received the maximum award of \$50,000 for each participating county. ODVA, in partnership with each county or transportation district, leverages these dollars in conjunction with existing programs and innovative new approaches to medical transportation in order to get the maximum value from each

Tapping into existing programs has enabled these grant dollars to make a significant and immediate impact for rural veterans in need of medical transportation services.

Last year, the 10 participating counties drove over 274,600 miles as part of this program and spent a total of 9,871 hours on the

Free transportation to and from medical appointments (not just those at VA facilities) is available to any veteran living in one of the participating highly rural counties.

Services include door-todoor pick-up and drop-off in ADA-compliant vehicles, with assistance in loading or unloading at no cost to the veteran.

County pays Eastern Oregon **County Association dues**

Kimberly Lindsay, the executive director of Community Counseling Solutions, gave an update on the state of relations between the Oregon Health Department and Eastern Oregon Counties during a Grant County Court meeting Wednesday, Nov. 3.

She said, as rural counties continued to shrink in size, the state would likely take on more health responsibilities and begin to centralize services. She recommended communities stay engaged and advocate for themselves to make sure their needs were met.

The court also discussed paying dues to the Eastern Oregon County Association. The association advocates for counties who receive funding through programs like Payment in Lieu of Taxes and the Secure Rural Schools. Commissioner Chris Labhart and County Judge Scott Myers voted to pay the association dues of

Commissioner Boyd Britton advo-

cated for paying half of the county's dues. He explained his position, stating elected officials were already advocating for rural counties and had their best interests at heart.

The court voted 2-to-1 to pay dues to the association.

The court also approved unpaid time off for a Road Department employee, regular elevator maintenance for the courthouse's elevator and a credit card to cover business expenses for the department of the Justice of the Peace.
