TAXES RECEIVED
 No money was received in tax revenue for the Urban Renewal Agency during the 2018-2019 fiscal year. We anticipate receiving a total of \$30,495.57 in tax revenue for the 2019-2020 tax year.
INDEBTEDNESS INCURRED
 In November 2019, the City of John Day approved a loan of \$62,500.00 to the Urban Renewal Agency at a 3.5% annual compound interest rate.
USE OF RESOURCES
 No incentive payments were expended during the 2018-2019 fiscal year. Five property owners were awarded incentive payments in November 2019 for a total of \$47,148.32 and \$34.63 was spent on supplies. Unused money is considered a reserve for future urban renewal projects.

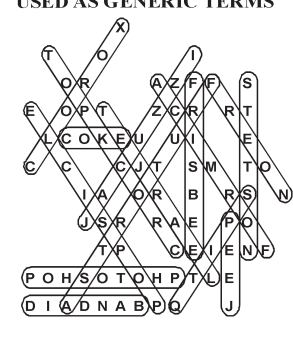
