## Two teens rescued from snow near Magone Lake

PRAIRIE CITY - The Grant County Sheriff's Office Search and Rescue Team located two teenage boys from Mt. Vernon whose lifted pickup truck got stuck in the snow near Magone Lake and returned them safely to their families.

The teens, ages 16 and 17, decided to take a spur-of-themoment drive to Magone Lake in the mountains north of Prairie City on the evening of Sunday, Jan. 16, via the less-traveled Beech Creek Road route and got stuck in deep snow, according to information from the Sheriff's Office.

Family members attempted to reach the teens but turned back to avoid getting stuck themselves and called the Grant County Emergency Communications Center at around 2:30 a.m. on Monday, Jan. 17.

The search team used cell phone pings to find the general area of the teenagers' last known location.

Using a Sno-Cat recently

acquired by the Sheriff's Office, Sgt. Dan Komning and Deputy Savannah Wyllie reached the missing youth shortly before 6 a.m. Monday.

The teenagers were OK when the search team reached them, but their truck had become stuck and mechanically disabled.

"Neither youth was prepared to spend a night out in the cold," the Sheriff's Office said in a press release.

The agency reminds the traveling and adventuring public that preparation is key to survival in the beautiful vastness of Grant County.

"We hope you explore safely and responsibly," the press release said, noting that short-notice, spur-of-the-moment trips usually cause the most problems.

"Always let someone know where you are going, and don't deviate from that plan," Sheriff Todd McKinley said in the press release. "Should you become stuck or stranded, please contact the Sheriff's Office at 541-575-1131 or call 911, and we will assist in getting you help."
