This Complaint claims that there is a default of a Promissory Note secured by a Trust Deed on real property located in Grant County, Oregon, more fully described in the Complaint.

Plaintiff prays for a judgment as follows:

- A general judgment declaring as due the principal amount of \$34,879.65 plus interest on the principal balance at the rate of 5.00% per annum from May 6, 2022, until paid, together with reasonable attorney fees and costs and disbursements. The judgment shall only be enforced through execution on the subject Property and shall not establish liability, personal or otherwise, beyond such execution.
- Declaring the lien of the Deed of Trust being foreclosed herein to constitute a valid lien against all of the Property and declaring that this lien is superior to any interest, lien, right, title or claim of Defendants in the property;
- Foreclosing Plaintiff's Deed of Trust lien and ordering the sale of the Property by the sheriff of Grant County in the manner prescribed by law; and that the proceeds shall be applied as follows: (1) First to the cost of sale; (2) Then to the satisfaction of Plaintiff's costs and disbursements incurred herein; the cost of the search and Plaintiff's reasonable attorney fees; (3) Then to satisfaction of Plaintiff's general judgment; (4) The balance, if any, to the clerk of the court, subject to further order of the court; and
