**Road Work**

Work that could affect traffic in Clatsop County next week includes:

- Tree-limb removal on Walluski Loop and Labiske Lane.
- Roadside brush chopping in Knappa and Elsie areas.
- Pavement crack sealing in the Knappa/Svensen area.
- Logan Road will be closed to all traffic until mid-November for construction on the Stave-

bolt Bridge. A detour is in place via Lewis and Clark Road. The bridge is 6 miles south of Miles Crossing.

- **Astoria-Megler Bridge:** Bridge painting work continues through September 2018. Delays of up to 20 minutes are expected.
- **Highway 101 Business:** Bridge rehabilitation on Old Youngs Bay and Lewis & Clark River bridges. Minor delays should be expected through November.
