ral transit agency, which has always been dependent upon timber revenue and property taxes.

With the assurance of nearly \$700,000 in new money every six months, that 20-year plan could be realized in just five or six years.

"You can have all these aspirations of what you want to do, but you have to figure out a way to pay for it," Hazen said. "Now we have the vehicle to get us where we need to be. ... We're going to be able to do some great things."

• Where's my bus? In January or February, the district will have an application available for smart phones that allows riders to track buses on their routes through a GPS locator. Not only will

riders be able to see where their bus is, the agency will have a way to get on-time data and see where the system should be tweaked.

• EFares. Projected by the end of sum-

mer, the district will impliment eFares to cut down on the amount of cash drivers must deal with. Riders can go online through their phone or computer to buy passes and add funds to the passes. Those with smart phones can use an eFare app and never need to present a card.

Discounts for seniors, students and those with disabilities will be built in when riders sign up.

EFares will help people get on the bus quicker because it reduces some of the things drivers do. The process of determining the number of riders and whether discounts are applied is a manual process now.

• Passenger counters. By the end of 2018, technology to accurately count the number of riders would be installed on all buses. It could be a red beam of light or something similar to a traffic ticket camera.

Transit agencies that use these devices report a 95 to 97 percent accuracy rate. Today, drivers push a button for every rider that steps onto the bus, which can lead to bad counts.

• Revised fare structure. Monthly passes could go down with some of the new technology, Hazen said. The agency will look at every route and determine the correct fare and figure out incentives to convince riders to pay in the most cost-effective way.

"That stems from my retail days," Hazen said. "When I worked for Costco, we were unique in that the typical retailer was looking at 'How *much* can we sell this for?' Costco looks at it and says,

'How little can we sell this for?' I know I can get more people to switch to monthly passes."

• Route improvements. Route 10, the main route serving Astoria and War-

mer, the district will impliment eFares to cut down on the amount of cash drivers must deal with. Riders can go online through their phone or

Route 15, which offers service within Warrenton and Hammond, would be increased in both frequency and area. With the new Walmart, more service will be added.

Route 101, which connects Astoria-Warrenton to Seaside, will be reworked to improve on-time rates and to increase frequency.

On. Dec. 18, the district announced it's adding additional service to Route 20 and to the Pacific Connector bus routes effective Jan. 2.

Both routes serve South Clatsop County and connect with the Tillamook County Transit bus in Cannon Beach or Manzanita.
