

# Cultural Trust wants to help agencies win grants

Cities, counties and other Oregon organizations that serve the public have a chance to get a piece of more than \$5 million in grant funding.

The Oregon Cultural Trust, along with groups that give grants for arts, historic and humanities work, is holding meetings in 14 areas of the state, allowing potential recipients to discuss projects and programming.

“There are more than 1,450 cultural nonprofits serving Oregonians,” said Aili Schreiner, manager of the Oregon Cultural Trust. “We want to make sure they know about the grant funds and significant programming resources that are here to support them.”

Clatsop County’s meeting is from 10 a.m. to 12:30 p.m. Tuesday, Feb. 20, at Clatsop Community College’s South County Campus, 1455 N. Roosevelt.

## Transit district seeks members for budget panel

In addition to grants, other statewide programming resources will be presented.

Statewide partners include the Oregon Arts Commission, Oregon Heritage, Oregon Humanities, Oregon State Historic Preservation Office, The Oregon Community Foundation and Portland’s Regional Arts and Culture Council.

Organizations encouraged to attend the “Conversations with Funders and Partners” are libraries, arts organizations, museums, cultural centers, historical societies, arts alliances, literary groups

and heritage organizations.

All cultural nonprofit organizations are welcome. Among the grant opportunities discussed are the Cultural Trust’s 2018 Cultural Development Grants. Grant guidelines will be posted on the trust’s website by Monday, Feb. 5, with an April 13 application deadline.

Last year, more than \$2.94 million was awarded. This year, grants will be awarded beginning in August.
