into her residence and to safety."

Local police soon were joined by Sgt. Joe Warwick of the Oregon State Police Fish and Wildlife Division.

He determined the aggressive mother elk would continue to threaten anyone it felt might harm her calf. Two agents from Oregon Department of Fish and Wildlife arrived with a trailer and tranquilizer darts.

Meanwhile, the elk charged more vehicles and

residents, including a sheriff's car that was taking a resident home through the cordoned-off area.

It took three darts before the mother was subdued about 10 p.m.

With the help of many local citizens, she was loaded into the trailer along with the calf and taken out of the area to an undisclosed safe location.

The State Police, on its Facebook page, lauded the teamwork put in by officers and residents.

The neighborhood was reopened about 11:30 p.m.
