said. "These people are going to have 6,000 square feet to live in. My house is 6,000 square feet."

Her husband, Gil, developed the housing project on Northwest 17th Place where they live immediately east of Pacific Seafood's proposed dormitory.

"We bought our house here 9 1/2 years ago," Scott Widdicombe said. "I consider the approval affecting the value of my house, not to mention my morale."

"When these houses were built, they asked for a zone change so they could build there,' Planning Commissioner Mike Moha said of Gramson's company.

"The length and breadth these guys have gone to ... is pretty amazing," Commissioner Chris Hayward said of Pacific Seafood. He compared the complaints to what would be made by those living in new housing developments built adjacent to older farming areas.

Added Commissioner Rvan Lampi: "I know this is above and beyond what we typically see."

The project has gone through five public hearings and an informational community meeting.

A public meeting of the Falcon Cove Beach Domestic Water Supply District Board will be held on Saturday 7 Dec 2019 at 09:30am at the Arch Cape Fire Station. The purpose of this Public Hearing will be for the Board of Directors to accept public testimony regarding a six month extension to the existing Ordinance declaring a Moratorium on new Water Connections (FCBWD Ordinance 2018O2) in the District. City Attorney Spencer Parsons reminded commissioners that they're required to apply the standards that exist in Warrenton's building code to determine whether they've been satisfied.

"It's not the Planning Commission's job to invent the facts ... or impose standards that do not exist in the city's land-use standards," Parsons said.

Commissioners agreed the conditional-use permit met the city's land-use requirements and they approved it 7-0.

"At the base level, what this is about is a company trying to solve a real problem that exists," said Michael Robinson, a Portland land-use attorney representing Pacific Seafood.

The application was to ensure the project meets the city's land-use requirements. Subsequent building permit applications must be submitted in the future.

The City Commission previously amended its development code by expanding the definition of hotels to include dormitories, and by allowing dormitories in industrial water-dependent business zones as long as the housing is for companies that qualify as a water-dependent business.
