Road work

WARRENTON

•A project repairing the Youngs Bay Bridge continues through 2021, with little impact to traffic except some single-lane closures at night for the contractor to move equipment. Most of the work is being done from below the bridge.

CLATSOP COUNTY

•Crews will be repairing a slide on Lewis and Clark Road, just past Reith-Larson Lane. Expect minor delays.

•Crews will be repairing a small slide on Aldrich Point Road and Owl Lane.

•County crews should be just about finished making repairs to the Beerman Creek and Rippet bridges south of Seaside. Work was expected to be complete by Dec. 31.

ASTORIA

•Work continues on the waterfront bridge project, which affects the north end of Sixth,

Eighth and Tenth streets downtown. Work on the odd-numbered streets has been completed. The project will cause disruptions in the area through June 2020.

•A project improving the intersection of Highway 30 at 30th Street in Astoria near the Desdemona Club could cause lane restrictions at various times through the end of the year. All work on Highway 30 would take place between 8 p.m. and 7 a.m. Sunday through Friday. Work on 30th Street would take place during daylight hours Monday through Thursday.

TILLAMOOK COUNTY

•The Farmer Creek Bridge on Highway 101 between Beaver and Hebo is being resurfaced and reconstructed, with flaggers in place, through June.
