Continued from Page 1 parking lot, it makes sense to start there," Engbretson said.

The gravel lot has seen little activity for two decades, ever since the city purchased it and removed an old house for the benefit of the city's fire department. The vision for the lot has changed in the past few years; city leaders now view it as essential to downtown revitalization.

Plans are to spend \$100,000 on the lot, funds that already

are sitting in the urban renewal agency's coffers. However, it may not be enough to make all the improvements desired.

"At some point, there should be some sort of central shelter, something not only to give people cover for eating, but also for ordering," Mayor Henry Balensifer said.

"In other cities, these do become moneymakers. The more food choices you put in a spot, the more people you attract."

"There are no findings that it was a homicide. The man had health problems and methamphetamine aboard, so it was more a matter of which box on the death certificate gets checked," Brown said. "He was very combative and unruly from the get-go."

Jimenez was arrested on suspicion of disorderly conduct and resisting arrest. Initially he was taken to Colum-

bia Memorial Hospital for medical clearance before being booked at Clatsop County

"Shortly after Jimenez arrived at the jail, he had a medical emergency in the sally port," a fortified entryway into the jail, Sheriff Matt Phillips wrote in a press release. "On-scene corrections medical staff and deputies began life-saving efforts immediately. Mr. Jimenez was transported to Columbia Memorial Hospital, where he later died."

Police Chief Matt Workman declined to comment on the arrest, referring all questions to the District Attorney's Of-

The Clatsop County Major Crimes Team and the Clatsop County Medical Examiner are investigating.

"Jimenez was under the influence when first contacted by police, and remained combative and uncooperative when he was at the hospital, Brown said.

The arrest and when he was being treated for medical problems were recorded on police body cameras, he added.
