City leaders disband WBA

Warrenton city commissioners took final action April 28 to disband Warrenton Business Association, a group of appointed representatives business who provided input on how money collected through business license fees should be spent.

Those doing business in the city pay annual fees of \$60, plus \$5 per employee.

The task of deciding how business fees can be spent now will be decided solely by the commission, which also chose to change what's eligible for business licence fee money.

The purpose of the fee initially was to provide revenue for "enhancing the business community." That

has been changed to enhancing the city's "economy and livability."

Other new uses for the fees:

•Purchases of public safety equipment.

•Blight and nuisance abatement, including improvement projects that will increase property values or visibility for businesses.

•Grants to the local Main Street program.

•Grants to nonprofit groups whose efforts improve the economic value or viability of businesses or business districts.

•Events that celebrate national, state or local holidays or festivals, such as public movies or games.

kind of economic development opportunities do we have based on the land we have," Mayor Henry Balensifer said.

During the past two years, the city conducted an available housing inventorv

and also participated in funds were kicked in by the a countywide housing needs assessment.

While this survey is similar, it's limited to business and industrial land.

"We have a lot of undeveloped industrial land," Balensifer said. This type of land provides "high-paying and long-term jobs."

Community Development Director Kevin Cronin is negotiating a contract and scope of work with Seattle-based Community Attributes Inc. to conduct the survey. And a group of area business leaders was appointed April 28 to put the survey into action, which could include devising strategies for marketing the available land.

"Success for this project, in my mind, depends on our ability to have a 'strategic' perspective in terms of the types of business sectors that we should ... support" with city policy, Cronin said. "It needs to be feasible, reasonable, and based on good data and economic trends."

Larger businesses that locate in Warrenton should be a "good fit," he added. They should respect local culture, offer living-wage jobs of \$17 per hour or more, offer career advancement, and, ideally, produce a product that's exported outside the county.
